> RE: Board of Public Works Advisory 2011-1 **Designated Procurement Units Report**

Dear Governor O'Malley:

Pursuant to the Board of Public Works (BPW) Advisory 2011-1, the Department of Human Resources (DHR) in consultation with the designated procurement units - Department of Budget & Management, Department of General Services, Department of Transportation and University Systems of Maryland (Voluntary Participant), is required to submit an annual report on or before November 1, 2012 on the results of the hiring agreement contract selection process for procurement contracts. The Board emphasizes that all procurements should be reviewed for hiring agreement status, including construction, maintenance, and services.

The State Fiscal Year (SFY) 2012 report covers the 4th quarter of SFY 2011 through the 3rd quarter of SFY 2012, with quarterly hiring trends of 23%, 36%, 20% and 21% respectively. During this period, DHR processed 305 hiring agreement contracts held by 219 contractors. These contracts resulted in 833 total job placements. The attached report indentifies:

- 305 agencies contracts held by;
- 219 contractors;
- types of contracts (clerical, security, nursing and janitorial);
- scope of work (clerical customer services, unarmed guard services, in-home health aide services and building maintenance services); and
- 833 job placement sources.

The report also identifies job placements by population group:

- 256 current Temporary Cash Assistance (TCA) recipients (SFY 2012);
- 5 children of current TCA recipients (SFY 2012) aged 14 and older;
- 476 former TCA recipients (SFY 2007-2011);
- 64 children of former TCA recipients (SFY 2007-2011) aged 14 and older;
- 23 Child Support Obligors; and
- 9 Foster Care Youth 18 25 years of age.

This year's report adds the Designated Procurement Units – Hiring Agreement Contract Screening process, additional contract award amounts with an increase in the number of contracts and details the number of persons offered employment through each hiring agreement.

Job market trends for State Contractors - Hiring Agreement Program purposes show that the largest employers were Abacus Corporation, Inc., Jones Networking Associates, LLC, Associated Catholic Charities and Watkins Security Agency, Inc. The highest concentrations of jobs were in the clerical customer services, security, nursing and janitorial sectors. During SFY 2011 and SFY 2012, state contractors hired Former TCA and Children of Former TCA recipients more often than Current TCA and Children of Current TCA recipients, respectively. This may be attributable to the promotion of the Work Opportunity Tax Credit program. The tax credit provides larger financial tax credit incentives for the larger Former TCA populations. This along with unlimited tax credits available to employers may account for larger job placements of Former TCA groups.

DHR will continue to work with the designated procurement units to ensure meeting all data reporting requirements specified in the BPW's Advisory.
