Introduction

This annual report is submitted in fulfillment of the requirement under Education Article, §7-1508, Annotated Code of Maryland. On or before October 1, and each October 1 thereafter, the Center for School Safety ("the Center") must provide a summary to the Governor and General Assembly of the following:

- The public schools in the local school system's jurisdiction that have a school resource officer (SRO) assigned to the school; and
- If an SRO is not assigned, the adequate local law enforcement coverage that will be provided to the public school.

Local law enforcement adequate coverage varies statewide, but generally may consist of the following:

- Sheriff's deputies working overtime to provide adequate coverage to public schools. This type of coverage is also supplemented by patrol deputies who would respond to calls for service at high schools that do not have an assigned SRO.
- SRO supervisors, who are not routinely assigned to a specific school, providing supplemental patrol service and respond to calls for service at the public high schools when needed.
- Maryland State Police troopers conducting school safety checks at public high schools in their area of patrol. These checks allow troopers to supplement SRO and local law enforcement coverage at public high schools.
- Officers/deputies who are not SROs are permitted access to the school's Wi-Fi system so they can check emails and conduct other official business while at the school or on school property. This opportunity allows for increased patrol coverage of schools and proactive positive engagement and outreach with students, administrators, and staff.

It is important to note that in any public school critical incident/emergency especially when the incident involves a threat to life safety there will be additional officers/deputies who would be dispatched to assist the SRO in responding to and addressing the incident/emergency. In these situations, off-duty officers/deputies in the area may also respond to provide immediate assistance.

The following sections of the report address the two statutorily required topics. The report outlines the SRO and adequate law enforcement coverage for each of the local school systems. Information related to the coverage or assignment for individual schools may be provided upon special request to the Center.

Chart 1: Number of Maryland Schools with assigned SRO Coverage versus Adequate Law Enforcement Coverage






Chart 2: Number of Maryland High Schools with assigned SRO Coverage versus Adequate Law Enforcement Coverage



- Allegany County Public School System (ACPS) consists of 22 public schools providing services for approximately 8,500 students.
- There are four primary law enforcement agencies with jurisdiction in Allegany County: Maryland State Police, Allegany County Sheriff's Office (ACSO), Cumberland Police Department, and Frostburg City Police Department.
- ACPS has five full-time SROs. Four SROs are primarily assigned to the three comprehensive high schools and one vocational high school. The remaining SRO covers the middle, elementary, and alternative schools in the ACSO jurisdiction. All high school SROs also visit the middle and elementary feeder schools in their jurisdictions on a regular basis throughout the course of a week and teach DARE classes at elementary and middle schools.
- ACPS plans to increase the number of SROs by three to four in the next few years.

- Anne Arundel County Public School System (AACPS) consists of 124 public schools providing services for approximately 83,300 students.
- Two primary law enforcement agencies within Anne Arundel County provide SRO and adequate law enforcement coverage: Anne Arundel County Police Department, and Annapolis Police Department.
- AACPS has assigned thirty SROs to public schools. Each high school, one alternative school, and seventeen of the nineteen middle schools have an assigned SRO.
- All elementary AACPS sites, and other AACPS locations not specifically assigned an AACPD SRO receive law enforcement coverage via uniformed patrol of the police jurisdiction in which the school resides.
- Additional law enforcement coverage arises on an ad-hoc basis dependent upon police staffing, local crime/community conditions, and other situationallydependent needs. Law enforcement partners frequently provide unscheduled visits, directed traffic enforcement, and a host of other outreach activities.

- Baltimore County Public School System (BCPS) is divided into eleven (11) precincts. The county consists of 174 public schools providing services to approximately 114, 000 students.
- At least one SRO is assigned to each secondary school in Baltimore County.
- The elementary schools receive security coverage on a rotating basis from an SRO assigned by the local precinct to serve schools that fall under the responsibilities of that precinct.
- In BCPS, eleven high schools will have two or more SROs assigned and two middle schools will have two SROs assigned.
- Four SROs have been provided as floaters to provide additional support to schools as needed.

- Baltimore City Public Schools System (BCPS) consists of 167 public schools providing services to approximately 80,000 students.
- At least one SRO is assigned to each high school in Baltimore City.
- Mergenthaler Vocational –Technical High School, Digital Harbor High School, and Edmondson-Westside High School will each have two SROs assigned to them.
- In two instances, two schools are located on the same campus and one officer will provide coverage for both schools. In one instance, three schools are located on the same campus and one officer will provide coverage for all three schools.
- All Baltimore City Schools without assigned officers are actively patrolled by the Baltimore City School Police Force Patrol Division. Officers are required to stop by on a daily basis to check in with administration and conduct a walkthrough of the building and campus.

- For the 2019-2020 academic year, the Calvert County Sheriff's Office (CCSO) is increasing SROs from 7 deputies and 1 supervisor to 10 deputies and 1 supervisor covering all schools within the system.
- There will be a full-time SRO at each of CCPS's 4 high schools and each of the 6 middle schools within the system.
- The middle school SROs will cover calls for services at the elementary schools as directed by the SRO Supervisor.

- The Caroline County Sheriff's Department and/or the municipal police departments of Greensboro, Ridgely, Denton and Federalsburg actively patrol all school campuses.

- The total full time staffing for the SRO unit serving CCPS will be one (1) sergeant, two (2) corporals, and ten (10) deputies. Additionally, two deputies on an overtime basis will supplement staffing for middle schools as well as feeder schools.
- Each public high school in the county will be assigned a full time SRO.
- Based on geographical location, some middle school SROs will be tasked with covering their respective feeder schools.
- The Carroll County Career and Tech School as well as The Gateway/Crossroads School will have an SRO assigned to their building; those are both classified as "other" schools.

- Dorcester County is a large county with long distances between schools. The DCPS and DCSO encourage officers to routinely visit elementary and middle schools throughout the county.

- During the 2019-20 school year, there will be SROs from the Frederick County Sheriff's Office (FCSO) assigned to nine of the high schools. The remaining high school will have a Brunswick Police Department (BPD) SRO assigned.
- While SROs are assigned to high schools, all of the FCSO and BPD SROs respond to and support the middle and elementary schools which feed into the respective high schools.
- The Frederick Police Department (FPD) has three SROs assigned to middle schools within Frederick City limits.

- Garrett County Public School System (GCPS) consists of 12 public schools serving approximately 3,800 students.
- There are four primary law enforcement agencies with jurisdiction in Garrett County: Maryland State Police, Maryland Natural Resources Police, Garrett County Sheriff's Office (GCSO), and the Oakland City Police Department. All GCPSs are covered by employees of the GCSO.
- GCPS will have six (6) full-time SROs assigned to various schools in the county. Each high school will be assigned a full time SRO. The remaining SROs will provide adequate coverage for the middle and elementary schools.
- GCPS maintains an MOU for SRO coverage with the Maryland State Police, Maryland Natural Resources Police, Garrett County Sheriff's Office (GCSO), and the Oakland City Police Department. All four MOUs detail the SRO coverage and encourage law enforcement to make routine visits to the schools throughout the county.

- The SROs assigned to high schools and middle schools will conduct walkthroughs of the feeder elementary schools at least once during the school day.
- Bel Air Elementary School and North Harford Elementary Schools will have two SROs conducting walkthroughs at least once during the school day.

- All SROs have electronic key card and camera access to their assigned school. Furthermore, all HCPSS surveillance cameras are shared with the Howard County Emergency Communications Center.

- Local law enforcement officers on duty are encouraged to stop by all elementary schools on a daily basis at the start and end of each school day. In addition, they are encouraged to check in with administration and conduct walk-throughs of the buildings and campuses several times weekly.

- MCPS works in collaboration with law enforcement partners from the Montgomery County Police Department, Montgomery County Sheriff's Office, Rockville City Police, and Gaithersburg City Police to assign full-time SROs to all 25 high schools.
- One SRO is primarily assigned to the main alternative school and provides assistance and support to the other two alternative school sites, as needed.
- Montgomery County Police, Gaithersburg City Police, Rockville City Police, and Takoma Park Police Officers who work geographic areas where MCPS middle schools, elementary schools, and other special schools are located will respond to calls for service, assistance, and/or critical incidents within their respective jurisdictions.

- The Adopt-a-School program was created to provide additional support by matching locally assigned sheriff's deputies and Maryland State Troopers to each public elementary school. The officers assigned to this program frequent their assigned school during patrols and provide direct assistance as needed to school administrators.
- The "School Over Watch" program provides increased presence of law enforcement officers at schools for a large portion of the school day. The program is beginning its third year of operation. The program provides for officers to proactively patrol both public and private schools in St. Mary's County during the school day.

- Crisfield Academy & High School will have one SRO assigned.
- All other schools receive routine patrols by local law enforcement agencies.

- The Talbot County Sheriff's Department and the Easton Police Department routinely patrol the public schools campuses and buildings. Each deputy and or officer is required by their supervisor to sign in on a log and do a walk-through of the building.

- All SROs assigned to a specific school also have responsibility for the feeder schools to their assigned facility.
- SRO coverage will be provided by Washington County Sheriff and the Hagerstown City Police.

- Wicomico County utilizes an SRO in the secondary schools and CHOICES Academy.
- SROs listed under 'other' provide adequate coverage to multiple "satellite" schools.
