In accordance with Section 20-605 of the Local Government Article of the Maryland Code, I hereby submit the following report concerning Telecommunications Tax revenues received by Prince George's County in FY 2021.

Section 20-605 of the Local Government Article of the Maryland Code requires the County, by ordinance, to impose a sales and use tax on telecommunications service at a rate of not less than 5%. The State law further mandates that the net proceeds of the revenue from this tax may only be used for expenditures of the County's school system, with at least 90% of the proceeds directed to operating expenses and the remainder directed to school renovation and systemic replacement projects. An administrative fee of 1% of collections remitted to the County is shared equally between vendors and the County to cover the cost of administering the tax.

In April 2002, the County enacted CB-37-2002, which imposed an 8% tax on the gross receipts for telecommunications services in the County with an effective date of June 1, 2002. In 2015, the tax rate was increased to 9% through CB-037-2015, which took effect on July 1, 2015. The tax rate remained unchanged at 9% as of the close of FY 2021.

During FY 2021, the County collected a net total of \$17,488,390 in Telecommunications Tax revenues. Of this amount, the County appropriated \$14,758,990 for school operating expenditures and \$2,729,400 for school Capital Improvement Program debt service expenses.
