Language on Page 181 of the Joint Chairmen's Report and Section 8-103(b) of the State Personnel and Pensions Article require the Department of Budget and Management (DBM) to submit quarterly reports to the Department of Legislative Services listing the grade, step, title, salary and incumbent of each position, including Flat Rate positions, in the Executive Pay Plan (EPP). These reporting requirements also request the detail on any one-time lump-sum increases given to employees in the EPP subsequent to the previous quarterly report. This report is submitted in compliance with both reporting requirements.

As you know, the Executive Pay Plan was established by statute in 1989, and salary adjustments to individuals in the EPP are intended to approximate annual step and grade adjustments received by State employees in the regular pay plan. A copy of the most recent report, providing information as of April 1, 2011, is enclosed. It is important to note that salaries reported for April have been temporarily reduced as a result of the Fiscal Year 2011 State Employee's Furlough and Temporary Salary Reduction Plan. It is also important to note that there were no bonuses paid during this quarter of FY 2011.
