Dear Ms. Gruber:

Section 8-103(b) of the State Personnel and Pensions Article requires the Department of Budget and Management (DBM) to submit quarterly reports to the Department of Legislative Services listing the grade, step, title, salary and incumbent of each position, including Flat Rate positions, in the Executive Pay Plan (EPP). These reporting requirements also request the detail on any one-time lump-sum increases given to employees in the EPP subsequent to the previous quarterly report. This report is submitted in compliance with both reporting requirements.

As you know, the Executive Pay Plan was established by statute in 1989, and salary adjustments to individuals in the EPP are intended to approximate annual step and grade adjustments received by State employees in the regular pay plan. A copy of the most recent report, providing information as of January 1, 2019, is enclosed. It is important to note that the salaries reported for January were increased to include the statewide cost of living adjustment. It is also important to note that there were no bonuses paid during this quarter of FY 2019.
