Dear President Miller and Speaker Busch:

Section 8-105 of the State Personnel and Pensions Article requires Secretary of Budget and Management to report to the General Assembly all amendments to the Standard Pay Plan approved during the previous calendar year on or before the 15<sup>th</sup> day of the next regular legislative session. 
