Dear President Miller and Speaker Busch:

Section 8-105 of the State Personnel and Pensions Article requires the Secretary of Budget and Management to report to the General Assembly on all amendments to the Standard Pay Plan approved during the previous calendar year on or before the 15th day of the regular legislative session. During calendar year 2017, one Annual Salary Review adjustment was budgeted and twelve new classifications were added to the Standard Salary Plan as follows:

- Annual Salary Review approved in the Fiscal Year 2018 Operating Budget Effective July 1, 2017.
 - o Motor Equipment Operator I (DVA), salary range \$25,502 \$39,574
 - o Motor Equipment Operator II (DVA), salary range \$27,046-\$42,102
 - o Motor Equipment Operator III (DVA), (DNR), salary range \$28,702 \$44,812
 - Veterans Cemetery Caretaker (DVA), salary range \$27,046-\$42,102
 - O Veterans Cemetery Equip Operator (DVA), salary range \$28,702 \$44,812
 - O Veterans Cemetery Supv (DVA), salary range \$32,364 \$50,818
 - O Veterans Cemetery Supt (DVA), salary range \$41,358 \$65,827
 - O Veterans Cemetery Mgr (DVA), salary range \$38,880 \$61,691
