Maryland Opportunity Zones Report

Fiscal Year 2020

Community Development Administration Projects

The Community Development Administration (CDA) provided financial assistance to 61 projects in FY2020 with 33 projects funded through the CDA Multifamily program, 16 projects funded through the CDA Energy program, and 12 projects funded through the Neighborhood Business Works program. All but one of these CDA projects were in a Priority Funding Area and were therefore considered "business projects" in §4-223 of the Housing and Community Development Article.

Every CDA Multifamily program financed in FY2020 was within a Priority Funding Area; 10 were colocated within an Opportunity Zone (Table 1). CDA multifamily financial assistance totaled \$265.2 million out of a total project cost of approximately \$991.7 million to produce 3,042 units (Table 2). CDA provided \$35.8 million to multifamily projects in Opportunity Zones with a total cost of \$313.2 million for 879 units.

Nearly all eligible CDA Energy projects were located in a Priority Funding Area—all but one—while five projects were co-located in Opportunity Zones (Table 3). The five Opportunity Zone projects received \$2.0 million in funding for 444 units and all 16 CDA Energy projects impacted a total of 1,449 units and totaled \$5.8 million (Table 4).

In FY2020, the Neighborhood Business Works program funded a total of 12 projects around the state, expending \$10.6 million in state funds to support \$36.4 million in total project costs (Table 6). All projects were located within a Priority Funding Area and three were co-located in an Opportunity Zone (Table 5). The three projects in Opportunity Zones were awarded a total of \$3.5 million, supporting \$7.8 million in total project costs.

Neighborhood Revitalization Program Projects

In FY2020, the Neighborhood Revitalization (NR) program funded 85 projects through the Strategic Demolition Fund (SDF) and Community Legacy. Every NR program was in a Priority Funding Area and considered a "business project" in §4-223 of the Housing and Community Development Article.

The SDF funded 27 projects around the state, totaling \$12.2 million out of a total project cost of \$73.1 million (Table 8). All but one were in Sustainable Communities while 15 were co-located in Opportunity Zones (Table 7), receiving \$9.1 million in SDF awards and \$65.9 in total project costs.

The Community Legacy program made 58 awards to statewide projects totaling \$6.0 million in funds and \$43.4 million in total project costs (Table 10). Of these awards, 56 projects were located in Sustainable Communities and 25 projects were co-located in Opportunity Zones (Table 9). Community Legacy funded the 25 Opportunity Zone projects with \$3.1 million for a total project cost of \$7.4 million.
