Maryland 2022 Opportunity Zone Report

Fiscal Year 2022



Department of Housing and Community Development FY22 Projects

The Department of Housing and Community Development (DHCD) provided financial assistance towards the development of 82 projects in FY2022 totaling \$981.8 Million in total project cost. This represents a 7.4 percent decrease in total project cost compared with FY2021 levels. Of the 82 projects, nine projects were funded through the Community Development Administration (CDA) Multifamily program, eight projects funded through the CDA Energy program, and 14 projects were funded through the CDA Neighborhood Business Works program. The Neighborhood Revitalization (NR) Strategic Demolition Fund (SDF) and Community Legacy Programs funded 51 programs in Opportunity Zone areas. All of these projects were in a Priority Funding Area and were therefore considered "business projects" in accordance with §4-223 of the Housing and Community Development Article.

Every CDA Multifamily project financed in FY2022 was within a Priority Funding Area – all but one. Nine were co-located within an Opportunity Zone (Table 1). Financial assistance for CDA multifamily projects totaled \$407.5 million out of a total project cost of approximately \$812.3 million to produce 3,778 units (Table 2). Within Opportunity Zones, CDA provided \$96.3 million or 23.6 percent of funding to multifamily projects with a total project cost of \$249.7 million for 863 units.

Nearly all eligible CDA Energy projects were located in a Priority Funding Area; eight projects were located in Opportunity Zones (Table 3). The eight Opportunity Zone projects received \$3.3 million in funding for 853 units. All 27 CDA Energy projects added 3,392 units and totaled \$16.5 million (Table 4).

In FY2022, the Neighborhood Business Works program funded a total of 22 projects around the state, expending \$9.3 million in state funds to leverage \$31.1 million in total project costs (Table 6). All projects were located within a Priority Funding Area, 64 percent or 14 of these projects were co-located in an Opportunity Zone (Table 5). The 14 projects in Opportunity Zones were awarded a total of \$6.1 million, leveraging \$27.3 million in total project costs.

Neighborhood Revitalization Program Projects

In FY2022, the Neighborhood Revitalization (NR) program funded 99 projects through the Strategic Demolition Fund (SDF) and Community Legacy. Every NR project awarded was in a Priority Funding Area and considered a "business project" in accordance with §4-223 of the Housing and Community Development Article.

The SDF funded 40 projects around the state, totaling \$28.3 million out of a total project cost of \$105.6 million (Table 8). All but two were in Sustainable Communities while 25 were co-located in Opportunity Zones (Table 7), receiving \$12.8 million in SDF awards and \$75.4 in total project costs.

The Community Legacy program made 59 awards statewide totaling \$6.0 million in funds and \$32.8 million in total project costs (Table 10). Of these awards, 57 projects were located in Sustainable Communities and 26 projects were co-located in Opportunity Zones (Table 9). Community Legacy funded the 26 Opportunity Zone projects with \$3.4 million for a total project cost of \$14.1 million.
