Department of Housing and Community Development FY23 Projects

The Department of Housing and Community Development (DHCD) provided financial assistance towards the development of 97 projects in FY2023 totaling \$1.7 billion in total project cost. This represents a 71 percent increase in total project cost compared with FY2022 levels. Of the 97 projects, 12 projects were funded through the Community Development Administration (CDA) Multifamily program, 12 projects funded through the CDA Energy program, and 17 projects were funded through the CDA Neighborhood Business Works program. The Neighborhood Revitalization (NR) Strategic Demolition Fund (SDF) and Community Legacy Programs funded 56 programs in Opportunity Zone areas. All of these projects were in a Priority Funding Area and were therefore considered "business projects" in accordance with §4-223 of the Housing and Community Development Article.

Every CDA Multifamily project financed in FY2023 was within a Priority Funding Area. Twelve were colocated within an Opportunity Zone (Table 1). Financial assistance for CDA multifamily projects totaled \$410.4 million out of a total project cost of approximately \$1.2 billion. This investment produced a total of 3,467 units in FY2023 (Table 2). Opportunity Zone projects within CDA provided \$136.2 million or 33.2 percent of funding to multifamily projects with a total project cost of \$312.9 million which produced 996 units.

All eligible CDA Energy projects were located in a Priority Funding Area; 12 projects were located in Opportunity Zones (Table 3). The 12 Opportunity Zone projects received \$5.3 million in funding which produced 1,319 units. All 22 CDA Energy projects added 2,499 units for a total project cost of \$9.6 million (Table 4).

In FY2023, the Neighborhood Business Works program funded a total of 28 projects around the state, expending \$34.6 million in state funds to leverage \$166.6 million in additional project costs (Table 5). All projects were located within a Priority Funding Area of which 17 were co-located in an Opportunity Zone (Table 6). The 17 projects in Opportunity Zones were awarded a total of \$9.7 million, leveraging \$44.8 million in additional project costs.

Division Program Awards for Fiscal Year 2023 Located within an Opportunity Zone



Neighborhood Revitalization Program Projects

In FY2023, the Neighborhood Revitalization (NR) program funded 119 projects through the Strategic Demolition Fund (SDF) and Community Legacy. Every NR project awarded was in a Priority Funding Area and considered a "business project" in assistance with §4-223 of the Housing and Community Development Article – except for three.

The SDF funded 54 projects around the state, totaling \$31.2 million and leveraging additional \$241.5 million in projects cost (Table 7). All projects awarded were in Sustainable Communities while 32 were co-located in Opportunity Zones (Table 8), receiving \$16.2 million in SDF awards and \$89.2 in total project costs.

The Community Legacy program made 65 awards statewide totaling \$8.1 million in funds and \$17.1 million in total project costs (Table 9). Of these awards, 62 projects were located in Sustainable Communities and 24 projects were co-located in Opportunity Zones (Table 10). Community Legacy funded the 24 Opportunity Zone projects with \$4.3 million for a total project cost of \$11.6 million.
