Dear Governor O'Malley and Chairmen:

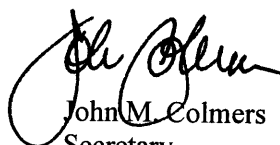
In accordance with the requirements set forth in Maryland Health - General Article, Section 13-1002(g) and Section 13-1102(h), the Department of Health and Mental Hygiene submits the enclosed Final Fiscal Report for fiscal year 2009 and the Interim Report for the first six months of fiscal year 2010, through December 31, 2009.

Funds available in fiscal 2009 were \$22 million for the cancer program and \$16 million for the tobacco program. There was \$609,272 unspent in fiscal year 2009. The unspent funds revert to the Cigarette Restitution Fund in accordance with Health - General Article, Section 13-1002(f)(1) and Section 13-1102(g)(1).

In fiscal year 2010, the legislative appropriation is \$12 million for the cancer program, \$4 million for the tobacco program, and \$15 million for the Breast and Cervical Cancer Program, which was added to the Cigarette Restitution Fund Program for fiscal year 2010. The combined unobligated fund balance for the cancer, tobacco, and Breast and Cervical Cancer programs is \$8.8 million, after six months of operations.
