## ANNUAL REPORT – 2013

This report covers the activities of the Maryland Board of Professional Counselors and Therapists for the period ending December 31, 2013

The Maryland Board of Professional Counselors and Therapists functions under Health Occupations Article, Title 17, Annotated Code of Maryland. The State Board of Professional Counselors and Therapists (the "Board") is the licensure and certification authority of professional counselors; marriage and family therapists, art therapists, and alcohol and drug counselors in the State of Maryland. The Board is mandated to regulate the practice of professional counseling and therapy in Maryland by licensing and certifying qualified counselors and therapists, promulgating regulations for the practice of professional counseling, marriage and family therapy, art therapy, and alcohol and drug counseling, verifying credentials, issuing licenses and certificates, establishing requirements for and verifying completion of continuing education hours, investigating complaints based on alleged violations of regulations and statutes, formal and informal disciplining of licensees and certificate holders, establishing committees as deemed appropriate to advise the Board, and submit an annual report to the Governor and Secretary.

#### **Mission**

The Mission of the Board of Professional Counselors and Therapists is to protect the citizens of Maryland and to promote high quality health care in the field of professional counseling, alcohol and drug counseling, marriage and family therapy, and art therapy.

#### **Meetings**

During the year, the Board held 10 formal meetings and monthly committee meetings.

## **Board Members**

The Board consists of 13 members: four licensed clinical professional counselors, three licensed clinical alcohol and drug counselors, three licensed clinical marriage and family therapists, one licensed clinical professional art therapist, and two consumer members.

## **Finances**

The Board of Professional Counselors and Therapists is special funded. Revenues, which support the Board's operations, are generated through licensing and certification fees. No other State funds can be used to support the Board's operations.

The Board generated \$773,501 in revenues in 2013 and its expenditures totaled \$614,946.

## **Complaints**

The Board received 76 complaints in 2013. The number of investigations conducted during the year was 50. The Board issued 11 formal disciplinary actions. ## Legislation

# HB56 - State Board of Professional Counselors and Therapists – Criminal History Records Check – *Passed (Chapter Number 348)*

This bill requires all applicants for a license or certificate from the State Board of Professional Counselors and Therapists to submit to a criminal history records check (CHRC). An additional CHRC must be performed every six years. The bill also creates a new ground for disciplinary action if an applicant, licensee, or certificate holder fails to submit to a CHRC as required under the bill.

# HB1115/SB593 – Health Occupations Boards - License Renewal, Investigation of Alleged Violations, and Immunity from Liability – *Passed (Chapter Number 404)*

This bill authorizes each health occupations board to develop a secure electronic system for the distribution of a renewed license, permit, certification, or registration. Any such system developed must (1) be accessible to the public for the purpose of verification of a current license, permit, certification, or registration and (2) provide the licensee, permit holder, certificate holder, or registrant the option of printing a verification of the status of their license, permit, certificate, or registration. The bill clarifies that *all* boards must investigate any alleged violation of their respective practice acts and that a person must have immunity from liability for giving information to *any* board or otherwise participating in a board's activities.






