> Re: State Finance and Procurement §13-224 (d) HB 268, Ch. 385, 2009 /MSAR 7666-Welfare to Work – Job Skills Enhancement Program – Green Jobs

Dear Senator Middleton and Delegate Conway:

House Bill 268 Welfare to Work – Green Jobs requires that on or before November 1 of each year and in consultation with the Maryland Association of Counties, the Secretary shall report, subject to Section 2-1246 of the State Government Article, to the Senate Finance Committee and the House Appropriations Committee of the General Assembly, on:

(1) The development of the local government hiring plan; and

(2) The number of current and former recipients, children of current or former recipients, foster youth and obligors hired and retained by local governments.

Development of the Local Government Hiring Plan

The Department of Human Resources (DHR), the local departments of social services (LDSS) and local governments maintain a hiring plan under which local governments may hire DHR's targeted population (current and former Temporary Cash Assistance customers, foster youth and child support

obligors). The plan has a "first source" requirement, which gives the targeted population first consideration for job openings, job interview and hiring decision.

Job Placement and Retention¹

During State Fiscal Year (SFY) 2013, in collaboration with the Maryland Association of Counties, a total of 1,631 customers were placed into jobs. The placements were in various sectors, including staffing and clerical support. The job placements for SFY 2013 were part of a comprehensive strategy that included intense trainings and internship programs provided to the customers. For example, partner agencies such as the Mayor's Office of Employment and Development provided participants services that allowed them to obtain the required skills and learn effective ways to present and write a résumé. A large concentration of hires were made in the three largest jurisdictions -- Baltimore City (580), Baltimore County (314), and Prince George's County (139). Overall, of the 1,631 total placements, retention data is available for 1,384 placements, of which 57.6 percent retained employment in a subsequent quarter. Additional details regarding the placement and retention is detailed in the charts below.
