REPORT REQUIREMENT

This report is hereby submitted in response to the following reporting requirement found under Family Law Article § 5-704.4(g)(2):

(g)(2) Beginning December 1, 2019, the Department of Human Services shall annually report to the Governor and, in accordance with § 2-1257 of the State Government Article, the General Assembly on:

(i) the number of reports of child sex trafficking made in the State in the preceding year;
(ii) the outcome or disposition of reports of child sex trafficking made in the State in the preceding year; and
(iii) the number of referrals made to regional navigators under this section in the preceding year.

BACKGROUND

The Department of Human Services has tracked data on reports of alleged child sex trafficking since 2013. Data collected includes the number of reports received by Child Protective Services (CPS), as well as the disposition of each investigation on a state-wide level. In 2019, the Child Sex Trafficking Screening and Services Act was passed into law, requiring law enforcement agents and local Departments of Social Services who have reason to believe a child is a victim of sex trafficking to notify a Regional Navigator in their jurisdiction or region to obtain needed services for the child. In 2019, three organizations were awarded grants to develop regional navigator programs in Cecil, Montgomery, and Washington counties. In 2020, seven additional organizations were awarded funding to develop regional navigator programs in the following jurisdictions: Anne Arundel, Baltimore, Frederick, Harford, Howard, and Prince George's counties, and Baltimore City.

CPS investigations can have one of three dispositions as defined by Family Law §5-701:

- **Indicated** -- a finding that there is credible evidence, which has not been satisfactorily refuted, that physical or sexual abuse, or neglect did occur.
- **Unsubstantiated** -- a finding that there is an insufficient amount of evidence to support a finding of indicated or ruled out.
- **Ruled out --** a finding that physical or sexual abuse, or neglect did not occur.

Below is the data on reports of child sex trafficking for Calendar Year (CY) 2020:

*Note: The seven (7) organizations awarded funding on October 1, 2020 (Anne Arundel, Baltimore, Frederick, Harford, Howard, and Prince George's counties and Baltimore City) required time to hire and onboard the Regional Navigator case managers. Many of those organizations received few if any referrals during this reporting period. The majority of the 42 referrals were made to the organizations that were awarded funding on October 1, 2019 (Cecil, Montgomery, and Washington counties).
