I herewith transmit on behalf of the Department of Labor, Licensing and Regulation and the Maryland Home Improvement Commission, the follow-up report required pursuant to Maryland Annotated Code, Business Regulation Article §8-204(c). I respectfully submit this report of the Maryland Home Improvement Commission for fiscal year 2014. This mandate requires the Commission to report attendance records of each Commission meeting (disaggregated by constituency represented), Guaranty Fund claims closed at each meeting, and open Guaranty Fund claims.

The Commission does not close complaints or claims during commission meetings. Closure of claims occurs during the course of many stages of litigation. The Commission has delegated the authority to open and close Guaranty Fund claims to the Executive Director.

The Commission is providing data consisting of the monthly total open claims to supplement the content of the report and provide a mechanism for trend analysis.
