Introduction

Natural Resources Article § 5-103 (The Reforestation Law) requires that on or before July 1 of each year, the department or local authority shall submit to the Senate Economic and Environmental Affairs Committee and the House Environmental Matters Committee a report on:

- (1) The number and location of each construction activity subject to the requirements of the Reforestation Law;
- (2) The amount and location of acres cleared, conserved, and planted in connection with the activity; and
- (3) The amount of reforestation fees collected and expended (1991, ch. 255, § 2.)

Construction Activities Subject to the Reforestation Law




Figure 1 – Location and Amount of Acres Cleared by County




Figure 2 - Location and Amount of Acres Cleared by Watershed

There were 11 projects subject to the Reforestation Law for FY 2007. Please see Table 1 and Figure 1 for a listing and a graphic of those projects by county. Please see Table 2 and Figure 2 for a listing and a graphic of those projects by watershed.

Amount and Location of Acres Cleared, Conserved, and Planted

The Department intends to use the monies received by the Fund late in FY '07 to fund activities under HB 1429 (2007), Reforestation - Replacing Trees Destroyed by Pest Treatments.




Figure 3 - Location and Amount of Acres Planted by County




Figure 4 – Location and Amount of Acres Planted by Watershed
