Introduction

Natural Resources Article § 5-419.(c) (Tree Expert Licensing Laws) states that the Secretary shall submit an annual report on:

- (1) The number of licenses issued;
- (2) The program receipts; and,
- (3) The program expenses for each fiscal year (1957, art 66C, sec. 405; 1973, 1st Sp. Sess., ch. 4, sec. 1.)

Number of Licenses Issued

The Department both renewed and issued new licenses for a total of 1,339 licenses.

Program Receipts
