Introduction

Natural Resources Article § 5-419.(c) (Tree Expert Licensing Laws) states that the Secretary shall submit an annual report on:

- (1) The number of licenses issued;
- (2) The program receipts;
- (3) The program expenses for each fiscal year (1957, art 66C, sec. 405; 1973, 1st Sp. Sess., ch. 4, sec. 1.)

Number of Licenses Issued

The Department of Natural Resources issued 67 new licenses during the fiscal year. At the end of the calendar year, 1,278 licenses were renewed. (Licensees are renewed by December each year).

Some licensees (57) were not able to renew their license because they failed to obtain the required eight continuing education credits. Others (43) either did not submit their renewal paperwork or were ineligible due to outstanding issues with the Comptroller's Office.

Program Receipts

Revenues posted to Source Code 5340, Tree Expert Licenses, total: \$22,865.00

Revenue sources include examination fees and license renewal fees.

Program Expenses

An Administrative Specialist (Grade 12, Step 17) 40% of time, total: \$20,483 Program expenses, total: \$ 1,300

Total: \$21,783
