PURPOSE:

Senate Bill 606, passed by the 2016 Maryland General Assembly, establishes the Commission's purpose. It is to ensure the educational success of returning veterans, including their recruitment, successful transition into higher education and eventual graduation. The Commission accomplishes this by facilitating the sharing of best practices, and potential adjustment of policies and procedures, among the institutions of higher education and state agencies regarding academic programs and support services designed for returning veterans. Commissioners, representing institutions of higher education in the state, address the following issues: awareness of veteran reintegration challenges; communication and coordination of available veteran services at the institution, state and federal level – including financial aid and GI Bill support services, mental health services and the use of career and transition services, at the education institution, to facilitate post-educational employment.

Specific Issues that schools have experienced:

- Betsy Atherton got a rejected invoice. Could there be a "counselor specific" issue. Whereas some would approve but others would not?
- Warriors to Workforce Program was told one counselor for all students, but now dispersed.
- Tiffany has also seen an increase in denied in Tungsten due to not having a match in tuition and fees. Was it due to health insurance?
- Dena's student was having a challenge as well so recommended submitting a congressional inquiry. Worked for one student but not the other.

- Random Google brought up a great option for getting responses and it's a White House Veterans Hotline 855-948-2311. The longest turnaround time is 36 hours. Have student call this hotline and it assigns a case number
- Around 40% of UBalt are VR&E 25% of that 40% still do not have POs.
- Dario from Towson asked Is it within purview of the commission to have a joint statement stating you need to fix VR&E Denise yes, we can, and other MD Commissioners have submitted their concerns as well. However:

 - The main concern for HCC with reporting the drops—when a full refund is issued to the student. We charge tuition and fees per credit, not a FT/PT rate, so our tuition and fees change based on the courses the student takes.
 - The new guidance indicates that even though the student gets a full refund, our certification with T/F need to reflect the initial certification—even if it is

a drop. We then go in and amend the cert to reflect the reduction of credits and the reduction of T/F.

- Per the guidance, the student is entitled to the payment for the # of days enrolled (even though it's a drop) as their 'pursuit'. This is going to create refunds for students.
- Sharon shows the incorrect certification/reduction a 29:09 in the video At about 32 she says that is incorrect and then shows that we should submit the original tuition and fees, even though it's a drop, and then do an amendment. This creates a refund to the student that the institution must process. For us, it is a huge mess as students add/drop like crazy—especially when they register way in advance of the start of term.
- It gets worse if its an add later than 7 days—then we create a unique nonstandard term
- Rebecca created drafts for each of the students to process after the drop date. Submit original enrollment and then at the end of the drop period submit what is used instead of tracking every drop
