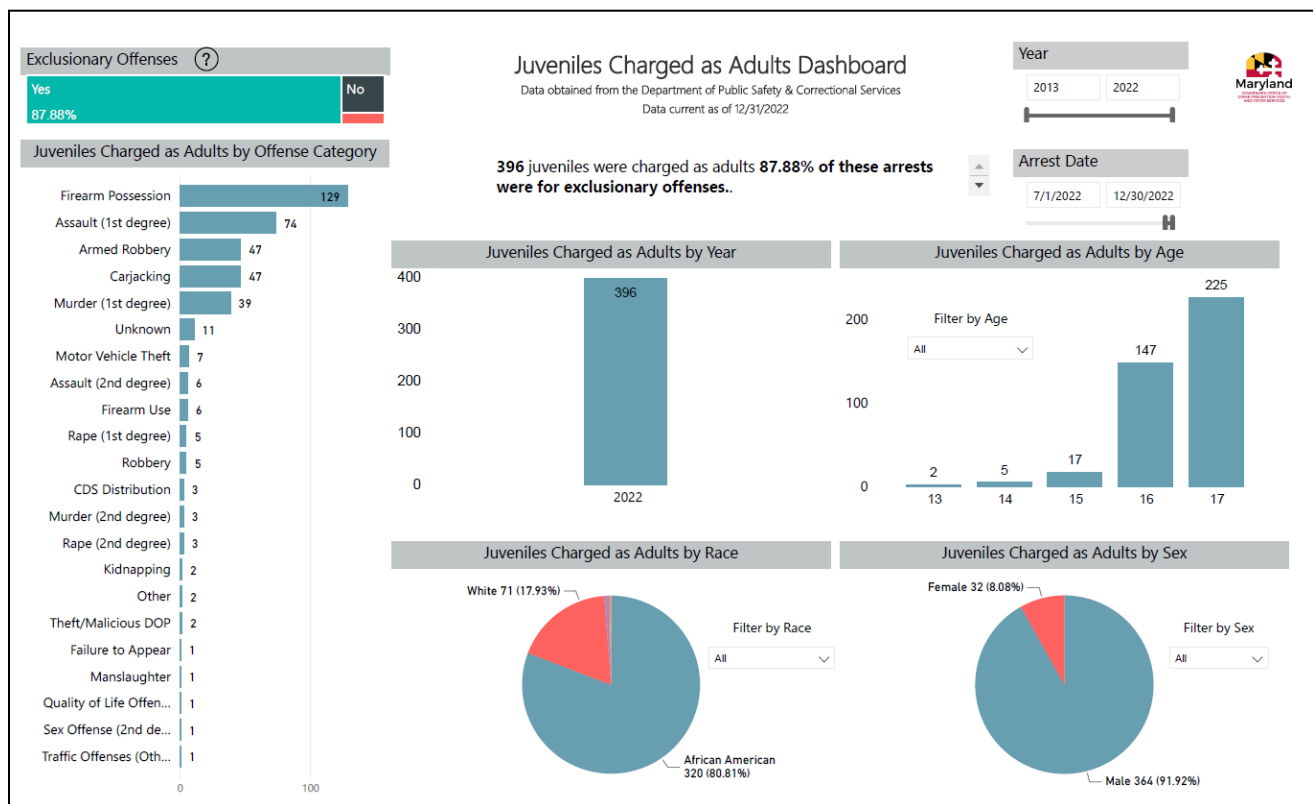

# Introduction

Chapter 252 of 2002 (House Bill 943) required the Criminal Justice Information System Central Repository (CJIS) to report information to the Maryland Justice Analysis Center on data pertaining to juveniles charged as adults in Maryland, to include the gender, race, and age of each.<sup>1</sup> It also required the Maryland Justice Analysis Center to report to the Governor and the General Assembly by June 30 and December 31 of each year, on the results of its research, evaluation, and statistical analysis on this matter. In 2007, the Maryland Justice Analysis Center moved to the Governor's Office of Crime Prevention, Youth, and Victim Services, and was renamed the Maryland Statistical Analysis Center (Center). Given this change, the Center submits semi-annual reports to the Governor and the General Assembly.

## Juveniles Charged as Adults

In accordance with § 10-219(b)(6) of the Criminal Procedure Article, this *Juveniles Charged as Adults* report provides specific information on juveniles charged as adults in Maryland between July 1, 2022 and December 31, 2022, based on aggregate data from CJIS (*as illustrated below*).

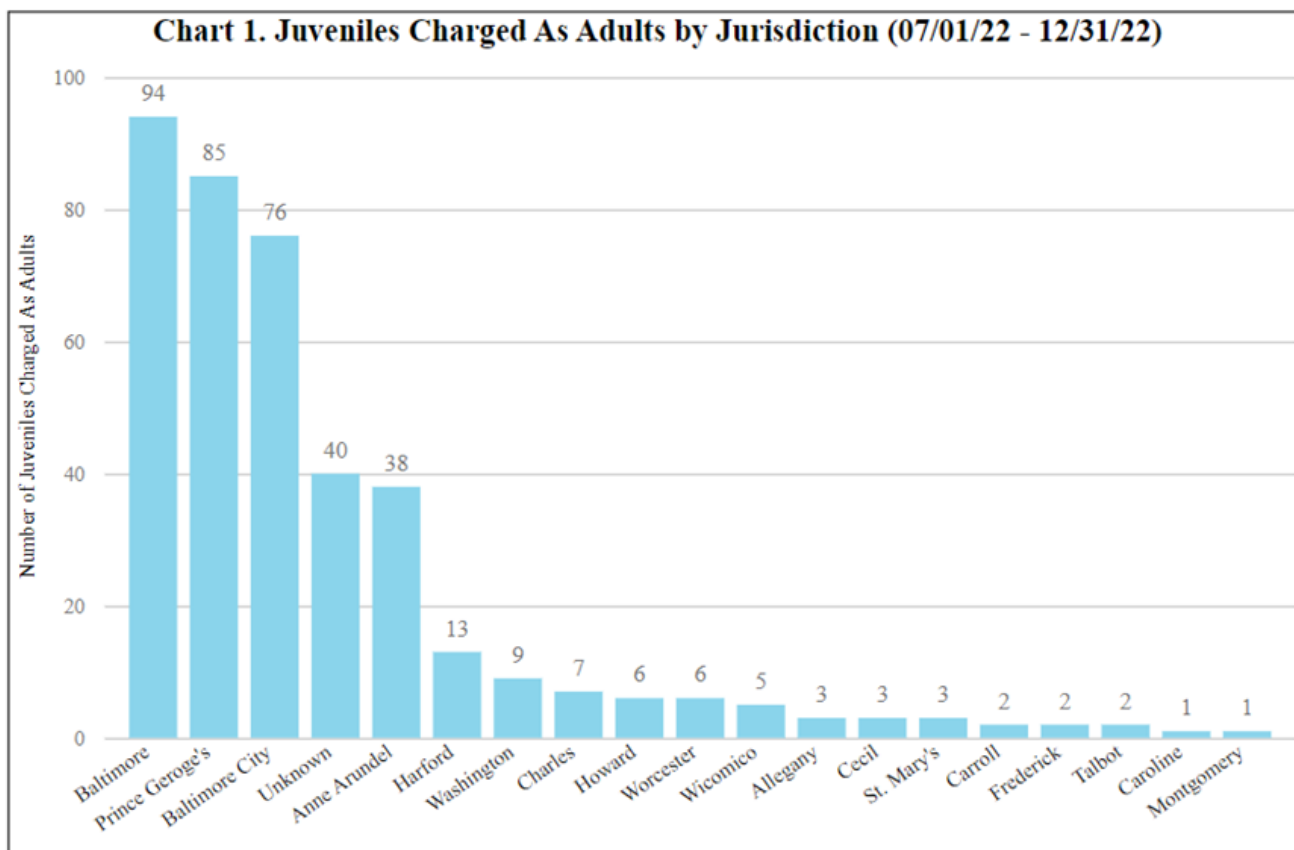

## Demographics

Between July 1, 2022 and December 31, 2022, a total of 396 juveniles were charged as adults in Maryland. The vast majority were male (91.9%) and between the age of 16 and 17 years old (93.9%). Most juveniles charged as adults were African American (80.8%), followed by White (17.9%). ## Jurisdiction

The majority of juveniles charged as adults occurred within three jurisdictions: Baltimore County (n = 94), Prince George’s County (n = 85), and Baltimore City (n = 76) (*as shown in **Chart 1***). Forty arrests also occurred in which the jurisdiction field was missing and, as a result, were coded as unknown. In addition, there were no arrests in the following jurisdictions: Calvert, Dorchester, Garrett, Kent, Queen Anne’s, and Somerset.



## Offense Type

Maryland law provides that juveniles who commit certain offenses must be charged as adults. These exclusionary offenses include the following:

As illustrated in the **Juveniles Charged as Adults Dashboard**, 87.9% of juveniles that were charged as adults during the second half of the 2022 calendar year were charged with exclusionary offenses that prohibited them from being charged in a juvenile court. Firearm possession was the most common exclusionary offense, followed by assault in the first degree, armed robbery and carjacking, and murder in the first degree. In addition, and based on the number of exclusionary offense arrests, there was a small difference between African American (88.4%) and White (85.9%) juveniles (*as shown in Table 1*). There was also a small difference between male and female juveniles who were charged with exclusionary offenses (*as shown in Table 2*).

**Table 3. Juveniles Charged with Exclusionary Offenses by Top Three Jurisdictions** illustrates the percentage of all juveniles, within the top three jurisdictions, who were charged with an exclusionary offense.

## Trends

As illustrated in **Table 4. Juveniles Charged as Adults Statistics by Year (2018 - 2022)**, the number of juveniles charged as adults decreased by 50.6% between 2018 and 2021, and then increased by 83.9% in 2022. The percentage of juveniles charged with exclusionary offenses increased from 79.3% of all arrests in 2018 to 87.2% of all arrests in 2022. In addition, there was little variation in the demographic make-up of these juveniles over the same period.
