This report details the activities and accomplishments of each element pertaining to the Maryland Spay and Neuter Grants Program for Fiscal Year (FY) 2022, covering July 1, 2021 through June 30, 2022. This report should be read in full, for complete context.

The end of FY22 marks the close of the eighth year of funding for the Spay and Neuter Grants Program. As of June 30, 2022, the program has funded 216 projects that have provided 95,558 spay and neuter surgeries for dogs and cats of low-income families, as well as community cat programs.

Nathanial Boan was promoted from the role of Spay and Neuter Grants Program Coordinator to the role of Executive Director of the Maryland State Board of Veterinary Medical Examiners in January 2022, and from that point until May 31, 2022, was working in both capacities. On June 1, 2022, Jen Swanson assumed the role of Program Coordinator. Formerly, Jen served as the Executive Director for the Baltimore Humane Society from 2011-2015, and for The Humane Society of Harford County from 2015-2022. Jen's background also includes working in various capacities from 2001-2010 in Baltimore City.

With this change, the program moved from the oversight of the Maryland Department of Agriculture (MDA) Marketing Director to the Maryland State Board of Veterinary Medical Examiners. This change means that Nathanial Boan will serve as Jen Swanson's direct supervisor.

The Spay and Neuter Advisory Board (SNAB) saw a couple changes in FY22, with outgoing veterinarian Dr. Tracy Stuller, and incoming veterinarian, Dr. Michelle Quigley. Dr. Quigley is a small animal veterinarian, working at a private practice in Charles County.

A significant accomplishment in FY22 was launching the One Stop portal for the program to begin accepting grant applications, quarterly and final grant reports, quarterly shelter surveys, etc. electronically, using webforms. Development started in FY21, and the project was completed in FY22, in time for grant seekers to begin using it in January 2022, to submit their FY23 applications. Having this portal allows for easier data gathering and sharing, increases program efficiency, and reduces the use of resources (paper, toner, etc.) resulting in cost-savings to the program and applicants/grantees.

During the 2022 legislative session, Senate Bill 206, an MDA departmental bill, was signed into law by Governor Larry Hogan. SB 206 extends the Spay and Neuter Program for 10 years, until September 30, 2032. Former program coordinator Nathanial Boan, MDA Assistant Secretary Cassie Shirk, representatives from the Pet Food Industry, local and national animal welfare organizations, and other stakeholders testified favorably on both bills, and there was no unfavorable testimony. Both bills passed unanimously in their respective committees, and overwhelmingly in the General Assembly. This legislation requires MDA to provide a report to the General Assembly on or before



October 1, 2022 with a list of spay and neuter programs that do not receive funding from the Spay and Neuter Program, the market capacity for increasing the fees assessed on each brand or product name, a proposed fee structure that can be implemented over the next 5 to 10 years to enhance the revenue generated from feed registrants, and additional sources of revenue for the program. The legislation took effect on June 1, 2022.

During the 2021 legislative session, Senate Bill 103 established the *Task Force to Study Canine Breeding Facilities and Sourcing Standards*. Nathanial Boan partnered with Cassie Shirk to provide staff support to the Task Force, which was charged with studying dog breeding facilities and online sales of dogs through breeding facilities. The Task Force met three times during FY22, beginning in July 2021, and a final report was submitted on December 3, 2021. The report outlines achievements over the past 20 years in combating substandard breeding practices, along with current efforts to address substandard canine breeding practices. Also, nongovernmental comprehensive standards for canine breeding were identified. Further, the Task Force recommended ways to align state breeding standards with those set by the U.S. Department of Agriculture, and any necessary legislative action necessary to meet those standards. The final report is available online and upon request.

In FY22, many projects and their partner veterinarians and agencies were still managing issues brought on by the COVID-19 pandemic. Supply shortages, cost increases and inflation (particularly cited by program managers were high gas prices, at the end of FY22), reduced volunteer hours due to health/safety concerns, staffing shortages in general, and more notably, the national veterinarian shortage, all combined to provide an incredibly challenging year. In addition, during FY22, shelters saw their intake and euthanasia numbers begin to increase as was expected, after a short-lived reprieve in FY20-21 during the first several months of the COVID-19 shutdowns. Thankfully, as of the close of calendar year (CY) 2021, they did not increase to pre-pandemic levels. Many shelters remained closed to the public either fully, or operated with limited hours, throughout FY22. However, our project managers and their teams remained vigilant, resourceful, and resilient; and continued to move their programs forward successfully, improving the quality of life for Maryland dogs, cats, and people in their communities.



GRANT PROPOSALS SELECTED

FY22 Funding Cycle:

For the FY22 funding cycle, the MDA received 36 applications with a combined request of \$1,214,547.80 for 20,568 surgeries. Of those 36 applications, 35 were approved; however, every organization that applied for a grant received funding for at least one of their programs. The total amount granted was \$850,318.68 for 14,446 surgeries. The grant application acceptance period opened on January 19, 2021 and closed on April 9, 2021. SNAB met virtually on August 11, 2021, and selected the following applications to recommend for funding. These recommendations were accepted by the Maryland Secretary of Agriculture, Joseph Bartenfelder, on August 16, 2021.

The following table summarizes the funded applications. They are in order of ranking based on the average cumulative scores by the SNAB.

Accomplishments for FY20 Funding Cycle Projects through FY22:

- All 30 of the approved projects have been launched.
- Twenty-nine of the 30 projects have been completed.
- Of the 29 completed projects, 22 projects (73% of the total projects) either met their target number of surgeries or exceeded their targets, five projects completed over 90% of their target surgeries, one project completed more than 85% of their target number of surgeries, and the lowest performing project completed 77% of their target surgeries.
- The one remaining active project received a grant extension until August 19, 2022 (FY23).
- As of the close of FY22, 15,256 of the 15,263 proposed spay/neuter surgeries (99.95%) have been completed.

Accomplishments for FY21 Funding Cycle Projects through FY22:

- All 29 of the approved projects have been launched.
- Twenty-eight of the 29 approved projects have been completed.
- Of the 28 completed projects, 24 projects (86% of the total projects) either met their target number of surgeries or exceeded their targets, and the other four projects completed 93% or more of their target surgeries.
- The one remaining active project received a grant extension into FY23.
- As of the close of FY22, 15,362 surgeries have been reported, exceeding the proposed 14,460 surgeries for this funding cycle (106%).

Accomplishments for FY22 Funding Cycle Projects:

• All 35 of the approved projects have been launched.



- Eight of the 35 approved projects have already been completed as of the date of this report.
- Of the eight completed projects, six projects (17% of the total projects) either met their target number of surgeries or exceeded their targets.
- As of the close of FY22, 6,816 of the 14,446 proposed spay/neuter surgeries (47%) have been completed.
- Staffing shortages in general, the national veterinarian shortage, increased costs for supplies, and other issues lingered throughout FY22 and into FY23, causing challenges for the program and grantees. The cost of gas at the end of FY22 was specifically cited by many organizations as it became very difficult to afford transportation of animals, and they saw decreased volunteer participation as a result, as well.

- Conduct visits to as many programs as possible.
- Solicit applications for FY24 funding in January 2023.

Accomplishments by Funding Cycle as of the Close of FY22:

- The cumulative target number of surgeries proposed by funded projects from all eight funding cycles thus far is 100,961 procedures. As of the end of the fiscal year, 95,558 or 94.6% of the total target number of surgeries were completed. This number includes the 29 active projects that are not yet complete.
- Of the completed projects (FY15 through FY19):
 - o FY15 cycle resulted in 5,133 procedures out of the 5,340 cumulative target procedures (96.1%)
 - o FY16 resulted in 8,267 procedures out of the 8,281 cumulative target procedures (99.8%)
 - o FY17 resulted in 13,654 procedures out of the 12,863 cumulative target procedures (106.15%)



- o FY18 resulted in 14,350 procedures out of the 13,944 projected (102.9%)
- o FY19 resulted in 16,940 procedures out of the 16,364 projected (103.5%)
- Of the three funding cycles with active projects at the close of FY22:
 - o FY20 projects have completed 15,256 surgeries (99.95% of the 15,263 FY20 goal), with one project still active at the close of FY22.
 - o FY21 projects have completed 15,362 surgeries (106% of the 14,460 FY21 goal), with one project still active at the close of FY22.
 - o FY22 projects have completed 6,816 surgeries (47% of the 14,446 FY22 goal), with 27 projects still active at the close of FY22.

- Close out the remaining active projects from FY20 and FY21.
- Continue managing the FY22 projects cycle.
- Fund as many projects as fully as possible from the pool of FY23 cycle applications, and manage the FY23 projects cycle.
- Provide oversight for all projects to ensure funds are dispersed to grantees as per each
 project schedule, that all reports and related project obligations are met, and to offer
 assistance and guidance to all project managers to help them reach or exceed their goals.



PUBLIC EDUCATION AND OUTREACH

The following summarizes the outreach efforts put forth with regards to the Spay and Neuter Program during the fiscal year.

Accomplishments for FY22:

- SNAB met on August 11, 2021 to discuss funding for FY23 projects. This was the second time
 that the board met virtually, due to COVID-19. The meeting was advertised on the MDA
 website two weeks prior to the meeting date and distributed to the media by the MDA's
 Public Information Office. Attendees from the general public were welcome, but none were
 in attendance.
- Program announcements were made on the department's website, on MDA's social media accounts (Twitter and Facebook), and on the program webpage.
- The program webpage is located on the department's website and is the main repository for all documents, materials, and information relating to the Spay and Neuter Grants Program. The program coordinator updated this webpage with additional information and materials. In addition, other helpful materials and information were added to the webpage to benefit grantees and the general public. The program website was updated and reorganized with the addition of the One Stop Portal launch. There were 42,135 unique visits to the program website in FY22.
- While the program normally produces materials to advertise the program through giveaways at events and meetings, due to COVID-19 causing most public gatherings to be canceled, no materials were ordered in FY22 to be given away.
- Former program coordinator Nathanial Boan attended the Maryland State Fair to promote the program, in 2021. Due to COVID-19, this was the only public event that the program was able to attend.
- A new program brochure was designed, and a small run of 500 was printed in June 2022.
- Each funded project performs outreach and education, not only about the services provided through their grants, but important general information about the need and benefits from the spay and neuter of owned pets and community cats, and where to find help, additional information, and resources.

- Continue to promote the program through all media available, including a focus on messaging via MDA social media.
- Explore the creation of an educational webinar series, recorded and available on-demand on the Spay and Neuter website, covering topics relevant for grantees/potential grantees as well as the public.
- With COVID-19 restrictions mostly lifted, attend as many public events as possible, in partnership with grantees providing programs in the area, whenever possible.
- Look for new ideas and materials to promote the program to the public and potential applicants.



ADVISORY BOARD

The Maryland Secretary of Agriculture appointed the seven-member SNAB on November 7, 2013. The board was tasked to make recommendations on the program guidelines and regulations needed to implement the state's Spay and Neuter Fund and each cycle, make funding recommendations to the secretary.

Accomplishments for FY22:

- From the program's start in 2013 and each year following, the goal of the SNAB and MDA has been to make each element of the program the best it could be. Each year, materials are developed, updated, and improved.
- During July through August 2021, the board carefully reviewed all 36 grant applications for FY22 funding. In anticipation of the formal review meeting, which was held virtually on August 11, 2021, each reviewer conducted their independent evaluations, and provided them to the program coordinator. These scores were used to rank the 36 applications to facilitate the discussion and help the board formulate funding recommendations that were submitted to the Secretary of Agriculture.
- Dr. Tracy Stuller, DVM left the SNAB on October 19, 2021.
- Dr. Michelle Quigley, DVM joined the SNAB on December 15, 2021, fulfilling the role of Veterinarian on the Board.

- Continue to strive for efficiency in the program and the processes.
- Continue to review and score FY23 grant applications, which have been under review since FY22.
- Hold annual meeting on August 11, 2022 to discuss and vote on formulating the funding recommendations to be submitted to the Secretary of Agriculture.



DEVELOPMENT OF PROGRAM ELEMENTS AND MATERIALS

Accomplishments for FY22:

- In FY21, former program coordinator Nathaniel Boan began working with the Enovational team to develop a One Stop portal for the program, completely overhauling how data is gathered from grantees and animal shelters. The quarterly shelter survey and quarterly grant reporting area of the portal was launched first, in October 2021. The grant application portal was launched in time for the FY23 grant application cycle, and all applications were submitted via the new One Stop portal. Legacy data for both shelter statistics and prior grant cycles was imported into the One Stop system as well. In addition, grant agreements will also be processed through the One Stop portal. The portal has significantly enhanced the efficiency of the program thus far.
- In June 2022, new program coordinator Jen Swanson designed an updated tri-fold rack brochure for the program and ordered a short run of 500 brochures.

- Conduct an annual review of all applications, reports, guidance, materials, website/webforms, and systems; update or improve as needed.
- Continue posting final reports from projects on the program's website as completed, update project list, and add missing reports not already on the website due to COVID-19.
- Continue to explore and develop new tools for applicants and project managers.
- Continue working with Enovational to fine tune the One Stop portal, and address any such issues as they may arise.



FEE COLLECTION

The program is funded from annual fees levied on manufacturers of all dog and cat feed and treats registered with the Maryland State Chemist Office. The following lists the accomplishments in fee collection during this period. By law, the program must invoice registrants for the annual fee during the first week of October, and payments, whether made immediately or any time subsequent to the invoice date, are good only until the following October. The registrants are asked to review the invoice and product list on which the fee was calculated. They were instructed to delete any products no longer sold in Maryland or did not meet the definition of "cat or dog feed or treat" or add any new products that may have been missing from the list.

Accomplishments during FY22:

- The program coordinator requested that Maryland Department of Information Technology (DoIT) generate the invoices and, based on what was received, on October 8, 2021 sent 234 invoices for Spay and Neuter Program fees to feed/treat manufacturers, based on product information from the State Chemist products registration database. Each invoice was sent via first class U.S. mail and included an explanatory letter, a list of products on which the invoice total was based, and instructions as to where to send the payment. The total number of products invoiced were 9,571 for a total of \$957,100.
- The program coordinator maintained a program fee spreadsheet that served as the main repository of fee remittance information. The coordinator maintained all paperwork pertaining to each paid invoice.
- The program coordinator sent a second notice on January 4, 2022, and a third notice via USPS certified mail on June 6, 2022 to delinquent accounts.
- From the 2021-2022 invoicing cycle, of the invoices sent, a total of \$901,500.00 was collected as of June 30, 2022.
- Of the invoices sent, 10 invoices were canceled because the companies were either out of business or no longer sold products in the state.
- As of the date of this report, 17 companies had not yet paid the invoice fee. The total amount of the open invoices is \$26,800.

- The program coordinator is making a final attempt to collect the fees before submitting a list to the Central Collections Unit, and has been successful in contacting eight of the 17 companies, as of the date of this report.
- Pursuant to SB206/HB191 legislation, prepare and submit required reporting by October 1, 2022; and explore additional funding sources for the program.
- Update fee database as invoices are paid.
- Send out 2022-23 invoices by the first week of October 2022. The State Chemist's Office recently changed database systems, and therefore the invoicing process may change.
- Continue to process and track fee payments (both new and delinquent) as they come in.
- Work with the State Chemist's Office to help educate feed registrants and potential registrants about the Spay and Neuter Program and its fees.



SHELTER STATISTICS SURVEYS

As stipulated in SB 820, "beginning January 1, 2014, each county and municipal animal control shelter and each organization that contracts with a county or municipality for animal control shall report quarterly to the department on a form prescribed by the Department describing for the previous 3 months: (1) the number of cats and dogs taken in; (2) the number of cats and dogs disposed of, broken down by method of disposal, including euthanasia; and department describing for the previous 3 months." The following details what the program coordinator did during this reporting period to meet this requirement.

Accomplishments for FY22:

- As of the date of this report, 31 facilities report shelter data to the department. Of these facilities, 27 are municipal animal services agencies or nonprofit animal shelters that receive partial county funding, and four are private non profit organizations that do not receive county funding.
- In FY21, former project coordinator Nathaniel Boan began working with the team at Enovational to develop a portal for the program on the One Stop system. In FY22 the project was completed, and agencies could begin reporting their quarterly surveys via the portal in October 2021.
- The program coordinator entered this data into a spreadsheet database by organization, and analyzed the data for the complete CY14-21. The program appears to be having a significantly positive impact on its targeted metrics of shelter intake and euthanasia. The following graphs show the calendar year data that has been collected.
- While agencies saw a significant decrease in the number of intakes and euthanasia at the beginning of the COVID-19 pandemic, unfortunately during FY22, shelters across our state saw these numbers increase. This was expected, as we know that during COVID-19, shelter intake and euthanasia rates were unusually low.

- Post any missing reports on the program website for each quarter of data submitted, up to and including the first two quarters of FY23.
- Create a trend analysis report to be posted on the Spay and Neuter Program website.
