DEPARTMENT of GENERAL SERVICES FY 2015 STRATEGIC & TACTICAL MBE PLAN August 14, 2014 GOMA Report

I. **Program Description** of major ongoing activities of the program. Include in the Program Description an evaluation of the agency's FY 2014 performance, including a brief description of outreach efforts to MBE prime contractors and MBE subcontractors.

The Department of General Services re-structured its Division of Procurement and Logistics by creating the Office of Business Programs (OBP) in 2012. This was done in order to focus and maximize opportunities for small and minority businesses and to diversify our outreach efforts to all of Maryland's minority business community. OBP is continually assessing operational processes and outcomes and has put into practice new procedures for DGS's Procurement Review Group as well as MBE compliance and our efforts are now paying off.

MBE performance for FY 14' at 27.15% is an increase of 8.6 percentage points over the 18.55% achieved in FY 13'. This increase is due to a more comprehensive and practical approach to goal setting for DGS procurements. DGS began an effort to direct solicit MBE's on procurements which resulted in an increase from 196 total MBE prime awards in FY 13' to 269 in FY 14'. DGS committed to increasing its MBE participation in Commodities (Supplies & Equipment) from FY 13' and succeeded by increasing the percentage from 5.95% to 24.14%. The number of MBE primes in the Commodities category increased from 20 to 35 and MBE subcontractors increased from 15 to 27.

Outreach effort to MBE prime and subcontractors was conducted by partnering with sister state agencies and resource partners. We initiated, partnered and /or participated in 7 major outreach activities during the fiscal year, ten more than the previous year for an average of 3 events per month. The emphasis of the outreach was to promote eMaryland Marketplace, MBE participation on DGS contracts and the Small Business Reserve Program. The following is a list of those events:
