Re: Annual Report on the Construction Contingency Fund

Dear Senator Miller and Delegate Busch:

In accordance with Section 3-609 of the Annotated Code of Maryland, the Department of Budget and Management and the Department of General Services are required to submit an annual report to the General Assembly on the status and use of the Construction Contingency Fund (CCF) for each calendar year. This report will identify all monies appropriated to the Fund, authorized for expenditure from the Fund and expended from the Fund.

The CCF had a balance of \$4,482,754.39 at the end of calendar year 2013. The CCF will have a balance of \$2,088,457.22 on December 31, 2014.

During calendar year 2014, the Fund was increased by three (3) fund transfers by Board of Public Works (BPW) action agenda items as follows:


