In accordance with State Finance and Procurement Article Section 3-609 of the Annotated Code of Maryland, the Department of Budget and Management and the Department of General Services are required to submit an annual report to the General Assembly on the status and use of the Construction Contingency Fund (CCF) for each calendar year. This report will identify all monies appropriated to the Fund, authorized for expenditure from the Fund and expended from the Fund.

The CCF had a balance of \$5,235,080.98 at the end of calendar year 2019. The CCF will have a balance of \$8,180,218.47 on December 31, 2020. *

• The calendar year 2019 annual report had an incorrect ending balance; it is being corrected in this calendar year 2020 annual report.
