Activities

MDH posted an initial job announcement for the Director of Dementia Services and Brain Health position on August 26, 2022. The position was re-posted on October 18, December 14, 2022, February 23, and May 18, 2023. The position was filled July 26, 2023 by Jacquelyn Vok; while the position remained unfilled, Kristi Pier, Director of the MDH Center for Chronic Disease Prevention and Control (the Center), served in an acting capacity. In addition to the activities and recommendations described below, MDH provided staff support to the Virginia I. Jones Alzheimer's Council (the Council) in four quarterly meetings (July 27 and October 26, 2022, and January 25 and April 26, 2023) and four ad hoc legislative meetings (January 20 and 30, and February 7 and 9, 2023).

The Center applied to the Centers for Disease Control and Prevention's (CDC's) Building Our Largest Dementia (BOLD) Infrastructure's Public Health Programs to Address Alzheimer's Disease and Related Dementias (ADRD) funding opportunity (CDC-RFA-DP23-0010). On August 10, 2023, MDH was notified that it was selected as a grant recipient to receive funding for five years to conduct ADRD activities. The CDC will be awarding MDH \$500,000 annually for five years (total award \$2.5 million) with an award date of September 30, 2023.

MDH received one-time funds in the State Fiscal Year 2023 (SFY 23) Supplemental Budget for the purpose of funding Alzheimer's initiatives "in a manner consistent with the implementation of the recommendations of the Virginia I. Jones Alzheimer's Council." MDH consulted with key stakeholders, including the Council and the Maryland Department of Aging, to determine funding priorities and identify activities from the State Plan that could easily be initiated, scaled, and completed within a single fiscal year. Funding priorities included raising awareness of ADRD; providing outreach and education to the public, healthcare providers, and ADRD caregivers; and enhancing statewide ADRD data capabilities. Recommendations

The below are recommendations for the best use of the program's resources:

- 1. Establish a work plan with measurable goals and outcomes aligning with the BOLD Roadmap and the Maryland 2022-2026 ADRD Action Plan.
- 2. Incorporate brain health activities and messages into aligned healthy lifestyle and disease programming, such as cancer, diabetes, heart disease, physical activity, and nutrition.
- 3. Support the Virginia I. Jones Alzheimer's and Related Dementias Advisory Council to build commitment from partners across the state to implement activities from the ADRD Action Plan.
