In accordance with Health-General Article §18-214(k), the Statewide Advisory Commission on Immunizations (the Commission) is submitting this annual report to the Senate Education, Health, and Environmental Affairs Committee and the House Health and Government Operations Committee. The Commission is charged with determining where community vaccine shortages exist, developing recommendations for equitable distribution of vaccines, making recommendations for how to increase immunizations, and studying and marketing recommendations about other vaccine-related issues.

The Commission held two meetings in February and May of Calendar Year 2020. The

Commission continues to discuss how to utilize its standing to impact community education and uptake of vaccinations. The Commission also considered the following topics: the State's response to last year's influenza season, increasing childhood immunization rates during COVID-19, supporting and encouraging influenza vaccination for the 2020-21 season, and preliminary feedback for development of a COVID-19 vaccine. In addition, the Commission submitted a letter to the Governor encouraging him to promote messaging to parents to

complete their children's immunization schedules.

One of the Commission's goals in 2020 was to increase the scope of the Commission's outreach. This goal will continue through the remainder of 2020 and into 2021. The Commission will continue to explore partnerships with other agencies and entities to increase vaccine uptake and outreach. The Commission plans to hold an additional meeting before the end of this year to discuss COVID-19 vaccine distribution and monitor influenza vaccine uptake
