Dear Senator Beidle and Delegate Peña-Melnyk:

Pursuant to Health-General Article §4-310(g), I submit this response to the Protected Health Care Commission's (the Commission) semiannual report. The Commission is charged with making recommendations to the Secretary regarding sensitive health services that should be determined to be legally protected health care.

The Commission, established in 2023 by Health-General Article §4-310, is a nine-member body. Since its inception, the Commission has held five meetings, instituted a charter, and selected a chair. Additionally, the Commission reviewed the proposed COMAR 10.11.08 Abortion Care Disclosure regulations and provided helpful feedback regarding the regulations to Maryland Department of Health staff. The regulations were adopted on September 16, 2024.

The Commission created subcommittees to discuss gender-affirming care and miscarriage management as potential services to propose for determination as legally protected health care. The subcommittee work was paused while the Commission learned more about Electronic Health Record/Health Information Exchange (EHR/HIE) implementation plans and potential implications for the inclusion of additional codes. The Maryland Health Care Commission and seven EHR/HIE vendors shared implementation updates at the final Commission meeting of the year on October 22, 2024. The gender affirming care subcommittee presented collected codes

and data to the full Commission on February 27, 2025, and the Commission voted in that meeting to include the codes. At this time, the Secretary has not made a determination that there are new sensitive health services to be legally protected health care.
