Dear Governor O'Malley:

In accordance with Transportation Article, § 6-204, Annotated Code of Maryland, I am submitting this report as Chairman of the Maryland Port Commission on actions taken under this subsection during fiscal year 2013. Through this Article, the Maryland Port Commission is authorized to appoint up to a total of twelve management personnel to perform services for Maryland International Terminals, Inc. (MIT), the Maryland Port Administration's (MPA's) private operating company. The Commission was also granted the authority to determine the qualifications, appointments, and/or compensation needs for these employees. The statute directs that:

"On or before December 1 of each year, the Commission shall report to the Governor and the Legislative Policy Committee of the General Assembly on actions taken by the Commission under this subsection during the previous fiscal year with regard to individuals subject to the subsection."

During fiscal year 2013, the Port Commission took seven actions related to MIT employees as follows:

- Approved an increase for M. Kathleen Broadwater, Deputy Executive Director, to an annual salary of \$157,663 (PIN 889628).
- Approved an increase for David Thomas, Director of Operations, to an annual salary of \$141,358 (PIN 889364).
- Approved an increase for Richard Powers, Director of Marketing, to an annual salary of \$132,570 (PIN 889619).
- Approved an increase for Frank Hamons, Deputy Director Harbor Development, to an annual salary of \$102,838 (PIN 889454).

- Approved an increase for Vincent Marsiglia, Director of Finance, to an annual salary of \$122,645 (PIN 889370).
- Approved an increase for Douglas Matzke, Director of Engineering, to an annual salary of \$121,560 (PIN 889466).
- Approved the appointment of Cynthia Burman as General Manager of Cruise Maryland Marketing, at an annual salary of \$80,443 (PIN 889452).

The increases noted above were designed and voted on to reflect the cost of living and step increases given to State employees.
