In accordance with § 2-1257 of the State Government Article, the Maryland Department of State Police submits to you the report on the Law Enforcement Coordinating Council (LECC) and Regional Law Enforcement Coordinating Councils (RLECC).

The LECC convened two meetings in 2023. The first meeting was held on May 23, 2023. The second meeting was held on November 15, 2023. Intelligence related to criminal activity and deployment of police resources were briefed by participating agencies. Agendas and participants from both meetings are included in this report. No legislative recommendations were forwarded to the Chair during either meeting. The LECC has coordinated with GOCPYVS to update the 2024-2026 statewide crime strategy.

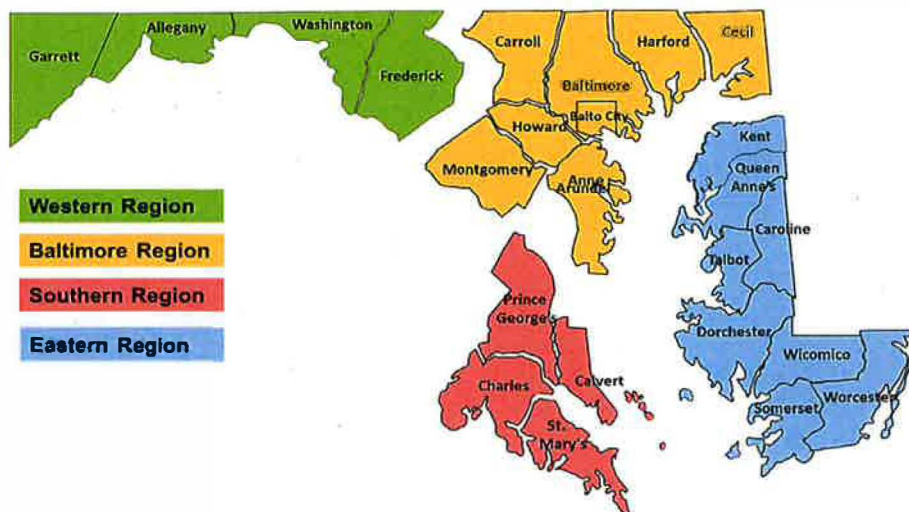
RLECC are designated as follows:
