Introduced during the 2017 Maryland Legislative Session and signed in to law by Governor Hogan on May 25, 2017, SB857/HB1275 created Veterans' Services Specialists in State Government to coordinate services with the Outreach and Advocacy Program Director in the Department of Veterans Affairs (MDVA). The Act took effect October 1, 2017.

MEETINGS AND TRAINING

- Meetings were held on June 25, August 22, and October 24
- Formal agendas were prepared for each meeting. For agendas, see Attachment A
- On November 21, the annual training took place in Crownsville. For agenda, see Attachment B

YEAR TWO ACCOMPLISHMENTS

- Three meetings held with an average attendance of 18 liaisons
- Liaisons toured the 175th Wing of the Maryland Air National Guard and visited with Active Duty Airman stationed at Martin State Airport, in addition liaisons learned about the Airman Care Team and the services they provide to National Guard members
- Liaisons were treated to a Baltimore Orioles Game in the Governor's Suite as a thank you for their service to our veterans
- Multi agency Day to Serve Project held at the MDVA Vietnam Veterans Memorial, volunteers from more than 10 state agencies weeded, mulched, cut trees, repaired flower boxes, and scrubbed the memorial wall
- Liaisons toured Melwood Veteran Services Operation Tohidu Program in Nanjemoy and learned
 of the services provided there, in addition liaisons were trained on military culture and the
 combat experience by Maryland's Commitment to Veterans, behavioral health resources were
 shared with liaisons
- Thank you letters sent to deployed Maryland State Police personnel (troopers and civilians)
- One annual training/information day held with an attendance of 69 VSS liaisons, human resources staff and state government employees who have served in the military
- During the information day, attendees received a refresher briefing on the VSS program, "Five Things You Need To Know" about VA Benefits, VA Healthcare, and Military Credits and State Retirement, upon the conclusion of the formal agenda, attendees visited 11 veteran related resource provider information tables
