Meeting Minutes

Deputy Stephanie Hull opened the meeting with the request that all attendees provide a brief description and update on the program or group that they represent and its work and challenges, and the attendees' objectives for their participation on the IAC.

The discussion and updates included:

- Identification of the workload and program challenges generated by public questions about the Affordable Care Act generally and open enrollment in Health Insurance Exchanges, specifically.
- Outline of the services and benefit programs available under the auspices of the Maryland Department of Veterans Affairs.
- Explanation of the housing rehabilitation loan programs for veterans, older people and people with disabilities.

- Description of an attendant care program covering among others people at risk of nursing home placement and other older adults.
- Outline of Memoranda of Understanding among State agencies covering peer outreach and support for beneficiaries of Money Follows the Person waivers; technical assistance to enhance "options counseling" and self-directed training for Community First Choice participants.
- Summary of role of regulation for multiple types of medical professions under the Board of Nursing and changes planned in the certification process for nursing assistants as well as the program for certified medical technicians.
- Various partnership programs to enhance communication access for people who are deaf or who have hearing impediments, including residents in long-term care facilities, and participants in various day programs for older adults.
- Initiatives of the State Commission on Aging including the summit between the state commission and local commissions on aging that included presentations and discussion of the concept of Communities for a Lifetime, its implementation in Maryland counties and how local commissions can help initiate and enhance such communities.
- The role of caregiver resource centers and certification funded by a state grant, of master trainers for caregiver resource programs.
- Efforts to "rebalance" the expenditure of Medicaid dollars such that the proportion spent on home-based services increases and that spent on institutional services decreases

Teja Rau of the MDoA gave a detailed presentation on the "Community First Choice" program; options counseling including that for people who would like to transition out of residence in long-term care facilities and initiatives that integrate the efforts of Maryland Access Point (the designation for Aging and Disability Resource Centers in MD), Centers for Independent Living and Area Agencies on Aging—including co-location of staff.

Discussion and Future Plans

A broad-based discussion of common issues and interfaces and specific questions from participants to other participants followed. This led to an expression of interest by participants in the IAC's becoming more proactive in facilitating information-sharing and integration of sometimes disparate initiatives. This was followed by the suggestion that the group conduct an internal survey on the fruitfulness of the information-sharing that occurred and the direction that this could take in the future.
