APPENDIX B: FY23 Grantees Receiving Multiple SEIF Awards

Appendix B lists individuals that have been identified by the Maryland Energy Administration (MEA) as receiving multiple awards from the Strategic Energy Investment Fund (SEIF) in FY23, or whose address has received multiple FY23 SEIF awards, as required by §9-20B-12 of the State Government article. Appendix B also lists nonprofit organizations, counties, local governments, and businesses with multiple SEIF awards in FY23.

There are several ways that nonprofit organizations, counties, local governments, and businesses can be eligible for multiple awards in a given fiscal year from the SEIF. For example:

- the Low-to-Moderate Income Energy Efficiency program is offered on a regional basis to ensure geographical diversity and an applicant can apply to provide energy efficiency services in more than one geographic area;
- the commercial Electric Vehicle Supply Equipment rebate program allows commercial entities to be eligible to receive multiple awards if multiple stations have been installed; and,
- entities can opt to participate in more than one energy program. Several counties and local governments participate in multiple MEA energy programs.

Like commercial entities, some of the ways that an individual can receive multiple awards from SEIF include by participating in more than one energy program (e.g., the Clean Energy Rebate Program for a renewable energy technology coupled with an incentive from the Electric Vehicle Supply Equipment (EVSE) Rebate Program), or by installing two different Clean Energy Rebate Program technologies (e.g., solar and a geothermal heat pump).
