Background

From July 1, 2012 to December 17, 2012, the Maryland Higher Education Commission has received 140 applications from Out of State institutions seeking registration to offer their fully online programs with the state. The Secretary of Higher Education has issued registration to 71 Out of State institutions; 30 Private (For Profit), 17 Private (Not for Profit) and 9 Public.
