

Fully Online Distance Education Program Registration Maryland Higher Education Commission MSAR #10646 Submitted June 2022 Reporting Period: November 1, 2020 - October 31, 2021

Executive Summary

Education Article §11-202.2(g) of the Annotated Code of Maryland requires the Maryland Higher Education Commission (MHEC) to submit to the Governor, and in accordance with §2-1246 of the State Government Article, the General Assembly, an annual fully online distance education program registration report. This report shall include:

- I. The number of institutions of higher education that apply for registration under this section;
- II. The type and size of the institutions that apply;
- III. The number of institutions approved for registration;
- IV. The number of institutions denied registration;
- V. The number of Maryland students enrolled in institutions required to register under this section;
- VI. The results of the requirements of §11-202.3 of this subtitle;
- VII. The number of institutions found to be in violation of the requirement to register under this section;
- VIII. Any fines imposed, and in what amounts, on institutions that violate this section; and
- IX. Any fine revenues collected from institutions for violation of this section.

Overview

Effective January 1, 2016, the State of Maryland became a full participant in the State Authorization Reciprocity Agreement (NC-SARA). As such, an institutional participant in NC-SARA is exempt from the requirements for the Registration of Online Programs in Maryland (COMAR13B.05.01). Additionally, effective January 1, 2016, Maryland's definition of operate in Maryland (COMAR 13B.02.01.03B(12)(c)) was amended to allow an out-of-state institution to place no more than 10 students in a single program, physically present at a single site in the State in a supervised internship, practicum, or field experience as a required part of a degree or certificate program. If more than 10 students from a single program are placed at a single site in the State in a supervised internship, practicum, or field placement, then the institution must submit an application for a certificate of approval to operate in Maryland.

Membership in NC-SARA has completely altered the online education landscape in the United States and in Maryland. Presently, there are 49 NC-SARA member states, the District of Columbia, Puerto Rico, and U.S. Virgin Islands with more than 2,200 participating institutions. Only California is not a NC-SARA member state. All NC-SARA member institutions may enroll

online Maryland students with no Maryland registration.

During the reporting period from November 1, 2020, through October 31, 2021, MHEC received a total of 44 registration applications including 4 initial applications and 40 renewal applications.

VI. Results of the requirements of §11-202.3 of this subtitle:

§11-202.3

At least twice a year, the Commission shall peruse federal databases and other information sources to determine whether there are Maryland students who are enrolled in a fully online distance education program offered by an institution of higher education that is required to register with the Commission under § 11–202.2 of this subtitle, but that has failed to register with the Commission.

In the instance that we determine that an institution is noncompliant or nonresponsive with registration requirements, MHEC staff will investigate such institution's website to determine if it has revised and published its policies on enrolling Maryland students after having received notice that registration with our office is required. Following the successful results of the investigatory letters that were sent out by MHEC, a number of institutions have voluntarily contacted MHEC staff to inquire about out–of-state online registration procedures or to announce their participation in NC-SARA. We continue to identify which institutions are located in NC-SARA states and are NC-SARA approved institutions, to determine whether an institution should be identified for further enforcement action.

With continued and increasing participation in NC-SARA by out-of-state institutions, the number of out-of-state institutions offering online distance education to Maryland residents required to register has not decreased in recent years and remains relatively the same at approximately 40-44 institutions for reporting periods November 2019 through October 2020 and November 2020 through October 2021. To date California is the only state that does not participate in NC-SARA.

VII. Number of institutions found to be in violation of the requirement to register: 0

In the past, a number of institutions were found to be in violation of the requirement to register as a result of MHEC's investigatory efforts summarized in Section VI. They were deemed in violation since it was determined that these non-registered institutions were already enrolling Maryland residents in fully online programs. However, as of this report, no institutions have been found to be in violation of these requirements; therefore, no fines have been imposed.

Conclusion

MHEC has seen continued decreases in the number of applications submitted through the out-ofstate online registration process. During Maryland's participation in NC-SARA, applications decreased over time from a peak of 165 in 2016 to a low of 26 in 2017. For the reporting period ending October 2021, online registration applications have increased to 44.

Students enrolling in online courses and/or programs continue to increase with the existence of and participation in NC-SARA. The NC-SARA Annual Data Report: Technical Report for Fall 2020 Exclusively Distance Education Enrollment & 2020 Out-of-State Learning Placements shows more than 5.5 million² student participants across the nation – up from the 3 million³ reported in Fall 2019. To date, 49 states, the District of Columbia, U.S. Virgin Islands, and Puerto Rico have joined NC-SARA. There are more than 2,200 individual colleges and universities that participate in NC-SARA.

Maryland's NC-SARA application was initially approved in 2015 and renewed in 2021. MHEC began implementing the agreement on January 1, 2016. As of October 2021, 35 Maryland institutions participated in NC-SARA enrolling a total of 178,466 students (129,373 Maryland residents and 49,093 out-of-state residents)⁴.

MHEC continues to manage the corresponding decrease in revenues for both online registration and out-of-state certificates of approval. MHEC has offset a portion of these losses by charging instate institutions an annual participation fee for NC-SARA. A contractual Online Education Analyst position coordinates both the online registration process and NC-SARA portal agency responsibilities at MHEC.

Despite an increase in distance education nationally due to the COVID-19 pandemic, MHEC did not see an increase in online registration applications. Instead, there was a national increase in the number of students enrolled in distance education coursework at NC-SARA institutions. It is likely

that non-Maryland institutions that could or needed to continue to provide in-person instruction did so, according to local and statewide mandates (just as the Maryland institutions did). MHEC has advised institutions that if they intend to permanently provide distance education for specific programs, approval or review is needed. Institutions that implemented temporary distance education for the primary purposes of student, faculty, and staff safety notified MHEC accordingly. MHEC will continue to monitor the situation and provide additional guidance as needed.
