Background

The Maryland State Department of Education (MSDE) is committed to ensuring that all students have the opportunity to engage in career and technical education (CTE) programs of study that align to high-skill, high-wage, or in-demand careers; lead to earning industry-recognized and/or postsecondary credentials that will allow entrance and/or advancement in a specific career field; and provide work-based learning experiences that require the application of academic and technical knowledge and skills in a work setting.

There are over 100 CTE programs of study implemented in Maryland public schools that are aligned to academic and industry standards and designed to fulfill Maryland's current and future workforce needs. A CTE program of study is a sequence of increasingly rigorous, non-duplicative courses that equip students with the knowledge and skills for entry or advancement in current or emerging professions. Statewide articulation agreements for each state-developed CTE program of study (except for cosmetology) allow students from any local school system to earn credits at two- or four-year colleges or universities. Industry partnerships provide the opportunity for students to complete internships, apprenticeships, or other workbased learning experiences. Enrollment in CTE programs continue to increase. In the 2020-2021 school year, 44.18% of Maryland public high school students are enrolled in a CTE program of study, representing a 9.3% increase from the previous year.

The goal for CTE is established in The More Jobs for Marylanders Act and Career Youth and Public Sector Apprenticeship Act, which states that by January 1, 2025, 45% of high school students prior to graduation will complete a CTE program of study, earn an industry-recognized credential, or complete a registered youth or other apprenticeship. The State Board of Education is required to provide an annual report to the Governor and General Assembly on progress towards attainment of the 45% goal. This report shares the progress towards attainment of the 45% goal by 2025.

Defining Career and Technical Education Completion, Industry Credentials, and Apprenticeships

The 45% goal established by legislation can be met through completing a CTE program of study, earning an industry credential, or completing a registered apprenticeship. Data shared in this report is informed by the definition for each of the aforementioned categories.

COMPLETING A CTE PROGRAM

CTE completion requires students to fulfill all requirements of a MSDE-approved CTE program of study and exit high school with a diploma or certificate.

EARNING AN INDUSTRY-RECOGNIZED OCCUPATIONAL OR SKILL CREDENTIAL

An industry-recognized occupational or skill credential is a verification of an individual's qualification and competence in a specific career area. Credentials are issued by a qualified third-party such as a vendor, industry association, or governing board after an individual has completed an assessment demonstrating proficiency for a specific skill set. Credentials are recognized by business and industry at the local, state, or national level.

Only state-approved industry credentials aligned with a MSDE-approved CTE program of study are identified in this report. This report identifies industry credentials earned by CTE concentrators prior to graduation. CTE concentrators are students that have completed two courses in a CTE program of study and have enrolled in a third course.

COMPLETING A REGISTERED YOUTH OR OTHER APPRENTICESHIP

Completion of a registered youth or other apprenticeship is defined as the completion of a work-based learning experience included as part of a school-to-apprenticeship program in collaboration with selected sponsors of registered apprenticeship programs, the Apprenticeship Maryland program, and/or other apprenticeship training programs approved by the Maryland Apprenticeship and Training Council (MATC) in accordance with § 11–405 of the labor and employment article.

Apprenticeship work-based learning experiences must take place at a work site and must be a paid experience (at least minimum wage) with a minimum of 450 hours. Youth apprenticeship programs are administered in partnership with local school systems. This report identifies registered apprenticeship programs, Apprenticeship Maryland programs, and other apprenticeship training programs approved by the MATC completed by students prior to graduation.

Baseline and Projected Data

In 2017, the Governor's Workforce Development Board, Maryland Department of Labor, and MSDE collaborated to establish projected targets to meet the 45% goal by January 2025. The December 2017 More Jobs for Marylanders Act Report identified that in the class of 2016, 22.84% of high school graduates completed a CTE program of study and 3.7% of students earned an industry credential as a CTE concentrator. At that time, data was not available on students completing a youth or other registered apprenticeship. Based on the reported CTE enrollment and program offerings in 2016, it was projected that to reach the 45% goal by January 2025, the following interim goals would be both ambitious and attainable:

Since 2016, CTE completion rates have shown an upward trend. Of the 58,887 high school students who graduated in 2021, **14,075** high school graduates completed a CTE program of study; **3,347** high school graduates earned an industry credential as a CTE concentrator; and **162** high school graduates completed a registered youth or other apprenticeship.

In 2021, many high school graduates completed more than one of the 45% measures (e.g., completed a CTE program and earned an industry credential, or completed an apprenticeship and earned an industry credential). The data in this report avoids duplicate counting of students. The 2021 outcomes reveal that 25.03% of the class of 2021 completed a CTE program, earned an industry credential as a CTE concentrator, or completed a registered youth or other apprenticeship as identified in <u>Table 2</u>. This demonstrates a slight increase from the prior year.

Based on analysis of actual outcomes reported toward the 45% state goal, local school systems in Maryland will need to increase the number of high school graduates who complete a CTE program of study, earn an industry credential, or complete an apprenticeship to nearly twice as many students (from 14,740 to 27,253). <u>Table 2</u> identifies the revised interim goals based on actual data from 2017 through 2021.

2021 Outcome Data

Data for this report was submitted by each of Maryland's 24 school systems and The SEED School of Maryland to the Division of Career and College Readiness and the Division of Assessment, Accountability, and Performance Reporting at MSDE in alignment with data collection protocols. Data represented in this report identifies the number of high school students who, prior to graduation, completed a CTE program of study, earned an industry-recognized occupational or skill credential as a CTE concentrator, or completed a registered youth or other apprenticeship.

Table 3 identifies the number and percentage of graduates in each high school that completed a CTE program of study, earned an industry credential as a CTE concentrator, or completed a registered youth or other apprenticeship. Once a student meets criteria for one category, then the student is removed from additional category counts. For example, a student that completed a CTE program of study and earned an industry credential is only counted as completing a CTE program of study. This avoids counting the same student multiple times in calculating the 45% goal attainment.

The table identifies:

- Total Number of Graduates Total number of students that graduated in the school.
- Total Number of Graduates that Completed a CTE Program Total number of students that graduated and completed a CTE program in the school.
- Total Number of Graduates that were CTE Concentrators and Earned an Industry Credential Total number of CTE concentrators that graduated and earned an industry credential. These students were not included in the count for CTE graduates that completed a CTE program of study or in the apprenticeship count.
- Total Number of Graduates that Completed a Registered Youth or Apprenticeships Total number of students that completed an apprenticeship. These students were not included in the count for CTE graduates or students that earned a credential.

The table also identifies the total number of graduates meeting 45% goal, percentage of graduates meeting 45% goal, and number of additional graduates needed to meet 45% goal.

STATEWIDE TRENDS TOWARDS REACHING THE 45% GOAL

<u>Table 4</u> identifies statewide trend data from 2016-2021 highlighting the progress towards the 45% goal of completing a CTE program of study, earning an industry credential, or completing a registered youth or other apprenticeship by 2025. Twelve school systems - Calvert, Caroline, Dorchester, Garrett, Harford, Kent, Queen Anne's, St. Mary's, Somerset, Talbot, Washington, and Worcester - consistently maintained over 40% of high school graduates meeting Maryland's 45% goal over the last six school years.

Next Steps

MSDE is committed to supporting school systems in meeting the 45% goal. MSDE collaborated with representatives from business and higher education to remove barriers towards goal attainment. The following supports were provided by MSDE to school systems:

- 1. Increased options for students to earn credentials by expanding the approved list of credentials and supporting dual enrollment options for students to earn credentials through credit and non-credit bearing community college pathways.
- 2. Provided grant opportunities for school systems to fund the cost of students to prepare for credentialing exams.
- 3. Provided grant opportunities for school systems to fund the cost of credentialing exams.
- 4. Increased the number of approved CTE programs of study.
- 5. Provided grants to school systems to expand CTE program offering.
- 6. Revised the course and credit requirement for students to complete CTE programs of study to focus only on content that is essential for entry into a career field.
- 7. Provided grant opportunities for school systems to expand apprenticeship programs.

The Blueprint for Maryland's Future revises the 45% goal for Maryland. The revised goal, as defined by the Blueprint, is by the 2030-2031 school year, 45% of high school students complete a registered apprenticeship or earn an industry-recognized occupation credential. The Blueprint establishes a CTE Committee and requires the Committee to establish, for each school year between 2023-2024 and 2030-2031, statewide goals that reach the 45% goal by the 2030-2031 school year. MSDE looks forward to collaborating with the CTE Committee to support statewide attainment of the 45% goal.
