Dear Governor O'Malley, President Miller and Speaker Busch:

Pursuant to Education Article Section 5-202 (d), the Maryland State Department of Education (MSDE) shall prepare an annual report for local Maintenance of Effort (MOE) on or before December 31 of each year to the Governor and the General Assembly. The Department should report all waiver requests, MOE calculations made by the Department, and the Board's decision regarding waiver requests.

On March 26, 2014, the State Board of Education received a formal MOE waiver request from Baltimore City. The City, with support of Baltimore City Public Schools, requested a waiver of \$2,925,582. On April 8, 2014 the Executive Director of the State Board of Education sent the Notice of Public Hearing to the office of the Mayor, City of Baltimore. In addition, on April 10, 2014 the notice was sent to the City School Board and Baltimore City Public Schools as well as posted to the Maryland State Department of Education web page announcing the hearing was to be held on April 22, 2014 and specified the procedures to be followed by the hearing parties.

After the public hearing, in which representatives of both parties spoke in favor of the waiver and after deliberation and verification of the calculations upon which the waiver request was based, the Board granted the waiver request on April 24, 2014.

MSDE received MOE certification forms from all 24 local school systems. With the approved waiver for Baltimore City, MSDE is pleased to report that all 24 local jurisdictions have met the fiscal year 2015 MOE requirement.

The attached forms provide a summary of the timing of the certification forms from the local school systems (Exhibit 1) and the FY 2015 required MOE amounts, by jurisdiction (Exhibit 2).
