In accordance with § 5-2-35(n) of the Education Article of the Annotated Code of Maryland, the Maryland State Department of Education (MSDE) is submitting this report regarding the Maintenance of Effort (MOE) required of local jurisdictions to the 24 local school systems for fiscal year 2024. The Department is required to report on all waiver requests, maintenance of effort calculations made by the Department and the county, the Department's decisions regarding waiver requests, the Department's certification of whether a county has met the requirement, and any other information relating to a county's request for a waiver and the Department's maintenance of effort decisions. The State Board received no waivers for FY 2024 MOE. All 24 jurisdictions have met the FY 2024 MOE requirement. The attachment table provides the MOE data by jurisdiction.
