Summary of Information Concerning Student Health, Well-Being and Growth

in Maryland's Local School Systems

April 2017

Pursuant to ED § 7-411.1

(MSAR #9854)

The Department of Curriculum, Accountability and Assessment at the Maryland State Department of Education (MSDE) has taken multiple steps to support and facilitate education concerning diabetes, its treatment and prevention, in addition to the topics of dating violence and oral health education in each local school system.

On multiple occasions since the passage of 2009 legislation encouraging dating violence education and 2012 legislation addressing diabetes and oral health, local school system health education coordinators were briefed on the requirements and provided clarification for specific standards that included the required information as well as the obligation to report its inclusion in local curriculum. Resources from state agencies such as the Department of Health and Mental Hygiene as well as outside advocate and medical groups were shared with local education agencies representatives. Time was dedicated at multiple briefings to allow doctors and other experts to address the group about the importance of the education and specific best practices for inclusion in lessons for students.

As a part of ongoing communication, the Office of Comprehensive Health Education has shared resources that are available for local education agencies through online newsletters and multiple other communication methods. Communication with local districts and partner groups is expected to continue on a regular timeline.

During the 2015 certification of the COMAR 13A.04.18, *Comprehensive Health Education Instructional Programs for Grades Pre-kindergarten – 12*, twenty-four local school systems certified that they had implemented a curriculum that includes diabetes, its treatment and prevention; oral disease prevention and dental health promotion and dating violence as part of their local Comprehensive Health Education curriculum aligned with the state Comprehensive Health Education Framework. Individual responses from school systems are included with this report.
