### **Background**

The Maryland Public Charter School Program is governed by Title 9, Subtitle 1 of the Education Article of the Annotated Code of Maryland. The statute requires the Maryland State Department of Education (MSDE) to report annually to the Maryland General Assembly regarding any updates or amendments made to public charter school policies by Local Education Agencies (LEAs) as well as the implementation of the Maryland Public Charter School Program on or before December 1 of each year.

The Maryland General Assembly enacted the Maryland Charter School Program in 2003, "to establish an alternative means within the existing public school system in order to provide innovative learning opportunities and creative educational approaches to improve the education of students." [Maryland Education Article 9-101 (b)].

The key provisions of the Maryland Charter School Law include the following:


- Local School Boards are the authorizers of public charter schools.
- Public charter schools comply with all State and local education laws and policies, unless waived.
- Employees of public charter schools are employees of the LEA.
- Charter schools receive an amount of public funding that is commensurate with the amount of funding expended on behalf of all public school students.
- Charter schools are open to all students. Admission is by lottery. Weighted lotteries are permitted in some circumstances.

### Overview of Maryland's Charter Schools

In the 2021-2022 school year, 48 public charter schools served 24090 Maryland public school students in six LEAs within Maryland. There are 32 public charter schools in Baltimore City, one in Baltimore County, nine public charter schools in Prince George's County, three in Frederick County, two in Anne Arundel County, and one in St. Mary's County. Figure 1 shows the number of charter schools and charter school enrollment by year.

Note: Monocacy Valley Public Charter School was approved by the Frederick County School Board in 2001, before passage in 2004 of Maryland's Charter Law.



#### RENEWAL AND APPLICATIONS

During the 2021 -2022 school year, 14 public charter schools completed a contract renewal review with their local board of education. Frederick County reviewed and renewed one charter, awarding a new 5year charter term. Baltimore City reviewed 12 charters. The Baltimore city board voted to close Independence School Local I at the end of the 2021-2022 school year. Ten Baltimore City charter schools were renewed for a three-year term. One Baltimore City school, Coppin Academy, was extended for one year to provide time to assess the partnership with Coppin State at the request of the new president of Coppin State.

Six applications for new charter schools were received by LEAsin the 2021-2022 school year.

### Activity by LEA:

- Anne Arundel County
  - One applicant submitted two times; the applicant was first declined, then approved after resubmission.
- Baltimore City
  - One application was received and declined for Shining Willow, a proposed elementary school.
- Frederick County
  - One application was received and approved for the Sabillasville Environmental School conversion project.
- Howard County
  - One application was received and declined for Reading Opens Doors elementary school.
- Montgomery County
  - o One application was received and declined for MECCA Business Learning Institute. The applicant has appealed to the Maryland State Department of Education.

#### **DEMOGRAPHICS**

Maryland's public charter schools serve a diverse array of students. Table 1 provides the percentage of students attending public charter schools who are eligible for Free and Reduced Price Meals (FARMS) and the percentage of students with disabilities (SWD). The percentage of students in all public charter schools who are eligible for FARMS is greater than that of the State. In Baltimore City, the percent of students eligible for FARMS and the percent of SWD are comparable. Outside of Baltimore City, a lower percentage of students eligible for FARMS or who have disabilities attend charter schools than traditional schools in the LEA.

### LOCAL CHARTER SCHOOL POLICIES [MARYLAND EDUCATION ARTICLE SECTION 910(A) AND (C)]

The State law requires that each LEA adopt a charter schools policy, post the policy to the LEA website, and provide the policy to the MSDE. In addition, each LEA is to identify a charter school liaison.

After passage of the Maryland Charter Law in 2003, each LEA adopted a charter school policy. Each LEA charter school policy contains the key requirements of the statute, including a definition of a public charter school, eligibility requirements for operators of charter schools, an overview of the LEA process for evaluation of applications to operate charter schools, and the process for earning a renewal of the charter. The initial term of a charter contract is five years and renewal terms are three or five years. Prince George's County is transitioning from a four-year initial term to a five-year term. No initial contract terms have been longer than five years.

All LEAs have identified a charter liaison, who is the point of contact for updates and technical assistance from the MSDE and also serves as the point of contact for any inquiry from the public regarding public charter schools.

Table 3 is a summary for each LEA and the most recent approval or review date for the policy.

### Technical assistance provided as required by Maryland Education Article Section 9 -110(b)(2)(i)

The MSDE regularly responds to requests for information and technical assistance from LEAs, charter school operators, and the public. Inquiries include questions from potential operators seeking guidance on the application process and parents seeking information about charter school enrollment.

The Director for the Office of School Innovations at the MSDE meets regularly with LEA charter liaisons. Attendance includes representatives from LEAs with and without operating charter schools. The meetings provide a forum for collaborative review of aspects of the charter law and challenges that arise in

overseeing charter schools. During 2020, this work resulted in a Guide to Charter Renewal and the creation of a shared online repository of local policy and process documents.

The Office of School Innovations through the Charter Schools Program grant has provided financial support to LEA liaisons to attend national trainings of the National Association of Charter School Authorizers.

# U.S. Department of Education Charter **Schools Program Grant**

In September 2017, the MSDE was awarded a grant from the U.S. Department of Education (USDE) Charter Schools Program. The award totals \$23,343,872 over five years through September 30, 2022.

Subgrants: Ninety percent of the Charter Schools Program grant funding is allocated for subgrants to nonprofit organizations operating or seeking to operate public charter schools in Maryland. The grants are available for the start-up costs of new, expanding, or replicating charter schools. Subgrants are awarded on a competitive basis.

Typically, there is a year of planning between approval of a charter school and opening. Charter school operators will propose plans for the planning year and initial one to two years of operation. Activities supported by the grant may include recruitment, planning, professional development, marketing, and technology acquisition.

The MSDE has conducted five subgrant competitions. The total amount committed to complete and active projects is \$15,226,405. There is \$5,117,486 available for new awards.

Completed projects have completed a three-year grant period.

- Baltimore International Academy (BIA), Baltimore City: To expand its original school, adding 325 seats over the grant period.
- Baltimore International Academy (BIA) West, Baltimore City: To replicate its existing K-8 program emphasizing language immersion in another Baltimore neighborhood. BIA West opened for the 2019-2020 school year.
- Chesapeake Charter School, St. Mary's County: Added 170 new students to its current K-8 program focusing on project-based learning and arts integration over three years, completing in June 2021.
- Chesapeake Math & IT (CMIT) North High School Expansion, Prince George's County: CMIT will add 300 seats to its STEM-focused high school program.
- Chesapeake Math and Information Technology Academy (CMIT) South, Prince George's County: To replicate its STEM-based school model, which is currently successful at three locations in the county. CMIT opened in fall 2018.
- Legends Charter School, Prince George's County: To open a new K-4 school with an intention of expanding to K-8, focusing on financial literacy and entrepreneurship. Legends opened in fall 2020.
- Watershed School, Baltimore County: Opened a new elementary school in the 2019-2020 school year with an environmental focus and extensive community outreach.

Projects underway are preparing to open or are in the first or second year of operation:

- Baltimore Montessori Public Charter School, Baltimore City: To expand this existing school, adding 230 seats.
- Clay Hill Public Charter School, Baltimore City: To replicate the successful Patterson Park Public Charter School. The school opened in September 2021.
- Empowerment Academy, Baltimore City: To expand enrollment at this existing arts-focused K-8 school.
- Monocacy Montessori, Frederick County: To expand this existing school by adding high school, starting fall 2023. This will be the first Montessori high school in Maryland.
- New Song Academy, Baltimore City: Converted this existing school to charter status in fall 2020 located in the Sandtown Winchester neighborhood.
- Phoenix International School for the Arts, Charles County: This is the first charter school in Charles County. The school will serve grades 6 through 12 and bring an arts program to the County. Opening fall 2023 with grades 6-8.
- Pimlico Elementary/Middle School, Baltimore City: Converted this existing school to charter in fall 2021.
- Sabillasville Environmental School, Frederick County: Converting existing school to charter in fall 2022.

One project is approved for grant funding but has not started, since the project is not approved by the LEA.

MECCA Business Learning Institute, Montgomery County: The school has proposed a business and finance themed program for grades 6 through 12. The Montgomery County School Board declined the charter application. The group is expected to appeal this decision to the State Board of Education.

A fifth grant competition was held in 2022. Five applications were submitted, three of the applications are recommended for funding but the full award process is not complete.

Technical Assistance: The grant enables the MSDE to increase technical assistance activities. Current and new charter operators can obtain guidance to determine readiness for replication or assistance to launch a school. Workshops address strategic planning, board development, addressing the needs of all students and other topics. The Maryland Alliance of Public Charter Schools (MAPCS) manages this work through a contract with the MSDE.

LEA authorizers also benefit from technical assistance and professional development opportunities to help ensure that application and renewal processes are equitable and rigorous. The grant has supported LEA staff attendance at the national conference of the National Association of Charter School Authorizers (NACSA), regular meetings of the charter school liaisons, and the creation of additional resources such as the website with local and national resources.

### Summary

Maryland's public charter schools operate as apart of the LEAs. Demographic data show that the charter schools are serving a diverse student body; however, there are still opportunities for growth to serve a student body that is more representative of the diversity of Maryland students. For example, charter schools should serve the growing student population of English Learners in Maryland. To serve these diverse student populations, it is essential that student application and enrollment lottery processes ensure equity and access for families in histoically underserved communities.

Performance data is mixed yet includes several examples of charter school students outperforming their peers in the LEA and the State. The charter school law has enabled the creation of models that have given families increased choices. The Charter Schools Program grants support the expansion and replication of high-quality schools and the creation of new, promising schools. Oversight of charter schools is the responsibility of LEA authorizers who set application timelines and standards of approval and renewal. Technical assistance support from the MSDE has helped the LEA staff collaborate on the development of more uniform guidance.
