Dear Governor Moore:

Section § 23-509 of the Education Article, Annotated Code of Maryland, provides for a grant program in the Maryland State Library Agency (MSLA) to assist in the funding of public library capital projects. Statute mandates that \$7,500,000 be included in the Governor's Capital Budget for this program each year, with an Annual Report to the Governor provided by the State Library Board on or before October 1. I am pleased to provide the attached report for ongoing projects and thank you for your support of libraries and this program.

Much of the work of the Agency and Maryland's public libraries aligns with and supports your priorities along several major themes:

- **Ending child poverty**

Libraries are leaders in providing essential early childhood education and family engagement initiative to communities, especially to those who are underserved and vulnerable. Early access to learning and development opportunities is proven to improve outcomes for children in relation to school success, educational attainment, health, and long-term economic vitality. Citizens rely on libraries for free access to educational programs and resources, including programs and services aimed at early learning and family engagement, inclusive learning opportunities for children birth to five and their caregivers, early childhood education and literacy programs, free, equitable access to reading materials that encourage a love of learning. In FY24, public libraries offered 41,080 children's programs that saw 1,326,622 participants. Overall, libraries offered 84,576 public programs with 2,171,049 attendees, a 15% increase in the number of programs offered and 18% increase in the number of overall attendees. **State capital funding enhances and expands library spaces to deliver programs to families and youth.**

- **Setting students up for success**

In addition to engaging in vital K-12 partnerships with county school systems and providing countless resources for students and teachers, **public library buildings offer much needed access to safe, constructive spaces and activities during out-of-school time** in the afternoon and summer through high-quality Summer Reading & Learning Programs in every county to STEM programs, college and career readiness, mental health support, and other targeted programs.

- **Equitable, robust and competitive economy**

Maryland public libraries are a critical part of communities' economic, educational, and workforce ecosystem. Libraries create new pathways to the workforce by expanding access to short-term credentialing programs and other programs that create a career ladder for participants, by supporting the development and deployment of programs and resources to help Marylanders of all ages gain skills, certification, and other credentials to participate in and shape the future of work. Libraries provide specialized assistance, customized in-person and online resources, and access to technology and skill building that is essential for job attainment. **An emerging theme in library design and innovation is the addition of small (2-4 person) work/study meeting rooms that provide customers with access to private, quiet spaces to accommodate a variety of individual's needs.** Libraries report these include, but are not limited to, tele-working spaces, interview rooms, consultation rooms (such as with legal or social work services) and telehealth. Demand for these rooms has grown dramatically over the past few years, from 90,909 in FY 2019 to 257,197 in FY 2024.

- **Connecting Marylanders to jobs**

Library workers actively guide citizens through all facets of the job search process, including exploring career options, test prep and civil services exams, resume development, interviewing, and networking. All offer online resources, websites, and **designated space and technology for job-seekers**, and many offer one-on-one assistance appointments that provide customized job search and technology instruction. Additionally, many libraries provide customized services to nonprofits, small businesses, and aspiring entrepreneurs through programming, information and networking, and online resources.

- **Creating safer communities**

A 2023 study in the Journal of cultural economics <https://doi.org/10.1007/s10824-023-09497-4> examined the relationship between public libraries and local crime rates. Previous studies have looked at different factors that could account for changes in crime, but few have focused on cultural institutions as a primary factor. Using crime data from the Crime Open Database and library data from the Public Library Survey, researchers leveraged the geolocation of crimes and libraries and explored the consequences of opening a new public library branch in Kansas City, MO, through utilization of a difference-in-difference strategy. **Results show that public libraries may reduce crime within its nearby proximity; in particular, there is a substantial reduction in frequency of burglaries, vandalism, robberies, fraud, and assaults.** However, such effects vanish in the distant proximity of the library.

- **Making a desirable and affordable home for all residents Maryland**

Libraries are community amenities that not only broker a wide range of resources to a community in a cost-efficient way, they are also proven to increase nearby home values and quality of life. A 2013 Pew Research Center study found that 95% of Americans ages 16 and older agree that the materials and resources available at public libraries play an important role in giving everyone a chance to succeed; 95% say that public libraries are important because they promote literacy and a love of reading; **94% say that having a public library improves the quality of life in a community**; 81% say that public libraries provide many services people would have a hard time finding elsewhere.

- **Advance infrastructure to better connect all Marylanders to opportunities and each other**

Libraries are community connectors and hubs, connecting all citizens to information and services from not only the library, but other community nonprofit, civic, and government organizations, including social workers, legal aid, food assistance, and mental health support. Libraries are increasingly used as places for community gathering and in FY24, use of public library meeting rooms increased by 22% over the previous fiscal year. Libraries prioritize accessible, inclusive government, and actively work to dismantle any barriers that prevent engagement by historically marginalized communities to improve the lives of all Marylanders. Public libraries reduce digital inequity by offering access to 5,216 public computer terminals at 192 branches across the State and via mobile libraries, providing critical access to information, employment opportunities, education and learning, and new skills. In FY 2024, public computer Internet usage increased by 5% to 2,252,313 sessions. Wireless access from personal patron devices connected to library broadband inside branches increased by 6% with 23,730,995 total wireless access sessions.

- **Ensuring a world class health system for all Marylanders**

Many public libraries provide health-based and other wellness programs to all community members and, in particular, veterans, as well as **telehealth and consultation space for community health providers through large and small meeting room spaces**. Libraries promote the health and well-being of Maryland's veterans through collaborations with stakeholder organizations to provide staff development programs and activities. Representative of all public libraries throughout the state, MSLA in partnership with the Maryland Department of Veterans Affairs, was awarded the Abraham Lincoln Pillars of Excellence award for Serving Those Who Served – a public library program to expand veteran outreach and library personnel education.

- **Leader in clean energy and the greenest state in the country**

The construction of public library buildings in the state has a growing emphasis on sustainable building practices and green features, including the use of solar panels and many other energy reducing technologies, as well as EV chargers, LEED features, and an emphasis on enhanced stormwater management methodologies. **Many of the State's public library buildings have become models for sustainable buildings in their communities, inspiring similar efforts**. MSLA worked with the Maryland Department of the Environment and the Department of Natural Resources to provide training to Library Administrators on the Climate Solutions Now Act and the Coast Smart Program in planning library capital projects in FY2025.

- **Making Maryland a state of service**

Through their own volunteer programs in addition to **serving as physical gathering sites for community and civic groups to organize initiatives, libraries are helping to advance service throughout all regions of the state**. Access to free, high quality community meeting space is critical for achieving this goal. Several of the State funded projects emphasize the improvement and expansion of library meeting spaces for the community.

Goals of the grant program include geographic diversity in the distribution of the awards as well as a wealth-based match formula to encourage local jurisdictions to fund urgent and necessary public library development across the State. Since the program was established in FY2008, all 24 public library systems have received awards for capital improvements. Similarly, the program has resulted in substantial local investment in public library facilities statewide. Fiscal Year 2025 was the fifteenth year that State assistance in the form of capital grants were available to public libraries in Maryland. Since FY2008 and including FY 2026, \$109,030,000 was authorized which generated an estimated \$384,000,000 in local matching funds. Library construction projects also generate jobs that stimulate the economy.

While the majority of the grant awards funded basic, but important, renovations including roof, window and HVAC replacement, an astounding number of 21 new public libraries have been opened with State funding from the Eastern Shore to Western Maryland providing lovely views of the Chesapeake Bay, local neighborhoods and the mountains. During FY2024, three new state of the art library facilities opened in Anne Arundel (Riviera Beach), Calvert (Twin Beaches), and Frederick (Middletown) Counties with support from the State. Construction of six new libraries is currently underway in Baltimore City (Park Heights) and Anne Arundel (Glen Burnie) Frederick (West Frederick), Garrett (Friendsville), Montgomery (Clarksburg), and Worcester (Pocomoke) Counties which will bring the total number of new libraries funded through this program to 27.

According to the most recent statewide facilities assessment conducted in November 2024, **more than half of the 192 public library buildings in Maryland are over 25 years old.** Consequences of this aging infrastructure are:

- 20 buildings need a new roof
- 17 facilities require alterations for ADA compliance
- 53 libraries have HVAC systems that are at the end of their useful life
- 50 buildings require technological upgrades in order to provide 21st century library services
- 69 existing facilities require general renovation and 18 buildings have been identified for replacement with a new structure

The estimated total cost of urgent and necessary projects during FY 2024 through FY 2028 was \$629.26 million. Only \$7.5 million in State funding is currently mandated annually to meet this need through the County Library Capital Grant Program, therefore, most of these projects are stalled. It is not unusual for total requests to exceed the \$7,500,000 mandated for the program. During the current FY2027 application cycle, MSLA received requests totaling \$16,280,000.
