### Introduction

The 2022 Joint Chairmen's Report (p. 106-107) requires the Maryland Department of Health (MDH) to submit a report on Maryland's Pre-Admission Screening and Resident Review (PASRR) program. PASRR is guided by federal regulations that require all individuals being considered for admission to a Medicaid-certified nursing facility (NF) be screened prior to admission to ensure appropriate placement in long-term care. Additionally, PASRR supports the advancement of person-centered care planning by assuring that psychological, psychiatric, and functional needs are considered along with goals and preferences in long-term care planning.

# PASRR requires Medicaid-certified NFs to:

- 1. Evaluate all applicants for Serious Mental Illness (SMI) and Intellectual Disability (ID);
- 2. Offer all applicants the most appropriate setting for their needs (in the community, a nursing facility, or acute care settings); and
- 3. Provide all applicants with the services they need in those settings.

### PASRR consists of a two-level assessment:

- 1. Level I screen to determine if an individual has SMI and/or ID.
- 2. Level II evaluation to determine if an individual with SMI and/or ID in the Level I screen needs a NF and specialized services.

The PASRR assessment must be completed before admission into a Medicaid-certified NF. The results are important in determining needs, appropriate care settings, and service recommendations to inform the individual's care plan. The timeframe for completing the evaluation is 7-9 days.

The 2022 Joint Chairmen's Report requests that MDH report on the following information:

- 1. A review of federal PASRR regulations;
- 2. The policies and procedures of Maryland's PASRR program and whether it complies with federal regulations;
- 3. A review of PASRR programs in other states, including regulations and opportunities to improve program efficiency; and
- 4. Recommendations, informed by the analysis conducted, for regulatory or statutory changes to improve the State's PASRR program and address any compliance gaps.

This information is described in the sections below.

### **Review of Federal PASRR Regulations**

The federal regulations governing PASRR are found in <u>Code of Federal Regulations at 42 CFR</u> 483.100-138<sup>1</sup> and provide requirements governing the responsibilities of states based on section 1919(e)(7) of the Act. These regulations include requirements outlining:

- 1. The PASRR evaluation and determination criteria for:
  - a. Eligibility and type of services to meet individual needs; and
  - b. Appropriate placement of individuals based on evaluation
- 2. The definition criteria for:
  - a. SMI and ID; and
  - b. Specialized services for individuals with SMI and ID.
- 3. The admission criteria for residents and applicants requiring:
  - a. NF services and specialized services;
  - b. Specialized services for MI or ID, but not requiring NF services; and
  - c. None of these services
- 4. The state plan requirements for preadmission screening and resident review program that meets §§ 483.100 through 438.138.
- 5. The annual evaluation of individual residents of Medicaid-certified NF with SMI or ID to determine significant changes in their physical or mental condition.

# Maryland's PASRR program and compliance with federal PASRR regulations

While Maryland does not have separate and distinct regulations addressing the PASRR process, the Code of Maryland Regulations (COMAR) and sub-regulatory documents governing Maryland's PASRR program have provisions guiding compliance to federal PASRR regulations. The current regulations, policies, and procedures guiding Maryland's PASRR program are:

- Code of Maryland Regulations (COMAR) 10.09.10 These regulations govern NF services and have provisions requiring facilities to comply with federal PASRR requirements as a condition of participation (COMAR 10.09.10.03B);
- 2. COMAR 10.09.30 Statewide Evaluation and Planning Services (STEPS) These regulations provide the requirements for the STEPS assessment, which is used as a tool for the PASRR Level II evaluation;
- 3. MDH memorandums related to the Local Health Departments (LHD) role in the Level II evaluation;
- 4. Transmittals issued by MDH related to PASRR; and
- 5. Behavioral Health Administration (BHA) memorandum on the role of older Adult Behavioral Health PASRR Specialists.

A summary of the policies and procedures are in Appendix A.

## **Evaluation of PASRR Programs in Other States**

PASRR program implementation varies nationwide. Some states, like Iowa, Indiana, and Utah, are working on the modernization, which will improve efficiencies of PASRR processes, to include the electronic collection and storage of PASRR-related data.

Additionally, according to a report published by the National Association of State Mental Health Program Directors (NASMHPD) on the use of technology to improve home and community-based options for adults with SMI, some key improvements on PASRR systems include dedicated staffing, implementation of a data management system, and enhancement of state policy and training. Appendix B summarizes some of these best practices select states are enacting.

### **Recommendations for Maryland's PASRR Program**

MDH is reviewing opportunities to enhance the PASRR program based on a review of the federal PASRR regulations, Maryland's existing regulatory and sub-regulatory guidance for PASRR, and best practices nationwide. Recommendations are summarized below.

- 1. Explore opportunities for updating the Level II Evaluation tool: Currently, MDH uses the STEPS assessment for the PASRR Level II Evaluation. The tool was developed by MDH over 30 years ago and benefits from local knowledge regarding the target population. However, with more information available today, compared to 30 years ago, this tool can be strengthened in its SMI and ID analysis. MDH is currently assessing opportunities to enhance this tool, including assessing how a recent standardized assessment, interRAI Home Care, used in subset of Medicaid home and community-based services, may be used.
- 2. Explore the enhancement of PASRR data management systems: MDH is reviewing opportunities to enhance the PASRR data management system. This can improve PASRR program efficiency and effectiveness by strengthening communications between the parties who manage the screenings and evaluations with respect to timeliness, accuracy, and completeness of information.
