## RE: 2022 Joint Chairmen's Report (p. 111) – Quarterly Community Services Data by Month - Q2 Report

Dear Chairs Guzzone and Barnes:

Pursuant to the 2022 Joint Chairmen's Report (p. 111), the Maryland Department of Health (MDH) respectfully submits its second quarterly report on the Developmental Disabilities Administration (DDA) Community Services utilization data collection and spending forecasts by month for the LTSS*Maryland*-DDA module. With this submission, MDH respectfully requests the release of funds associated with this report.

## Utilization by service type, including the number of claims and claims spending in the LTSSMaryland-DDA module - June 2022 - September 2022.

The first quarterly report included claims paid from November 1, 2021 through June 9, 2022. This second quarterly report includes June 2022 through September 2022. As noted in the below table, September's data includes claims paid through September 11, 2022.

## The number and share of individuals served through the LTSS*Maryland*-DDA module system.

The total number of individuals served through the LTSS*Maryland*-DDA module system, including the individuals receiving Personal Supports as part of Electronic Visit Verification (EVV) billing, is 7,056, or 36.6% of total DDA participants. The total number of individuals fully transitioned into LTSS*Maryland* (excluding those receiving Personal Supports) is 3,874, or 20.1% of total DDA participants. This represents a 6.6% increase of individuals receiving Personal Supports as part of Electronic Visit Verification (EVV) billing, and 25.0% increase of individuals fully transitioned into LTSS*Maryland* (excluding those receiving personal supports), since the first quarter.

In the first quarterly report, DDA calculated total individuals served through the LTSS*Maryland*-DDA module system by querying service plan data, which erroneously included some individuals still served through the PCIS-II system. We have corrected this error by querying only those providers in the two phases of the Early Adopter Group (EAG), in order to accurately characterize the number of individuals served through LTSS*Maryland*.

In this report, we amend the first quarterly report as follows:
