

# ANNUAL REPORT ON REGULATED FIREARM VIOLATIONS

**Summary**

Pursuant to HB0315/Ch. 714, 2024, this report presents the number of charges filed<sup>1,2</sup>, convictions, and sentences for violations of statutes related to regulated firearms, disaggregated by jurisdiction, race, and gender.<sup>3</sup>
