Foreword

This compilation was prepared by the State Department of Legislative Services pursuant to Section 2-1245 of the State Government Article. It is not intended to be an official updating of the Code of Public Local Laws, but rather was prepared to serve members of the General Assembly as a guide to the current status of the Public Local Laws in their counties and Baltimore City.

In 1983 the *Compilation of Municipal Charters of Maryland* was prepared by the former Department of Legislative Reference in conformance with Chapters 77 and 78 of the Acts of the General Assembly of 1983. A reprinting of the *Compilation of Municipal Charters* was issued in November 1990. In 1997, the General Assembly codified the legislation of the compilation and ratified the change in the name of the compilation to *The Public Local Laws of Maryland – Compilation of Municipal Charters*. The compilation is updated on a regular basis in accordance with Article 23A, Section 17B of the Code. As a guide and convenience to members of the General Assembly, the municipalities within each county are listed along with their chapter and volume references in the *Compilation of Municipal Charters* (1990 Replacement Edition). It should be noted that municipal corporations that are located in two counties are indicated by a double asterisk (**).

Page references in this document refer to the page number in the year of the Session Laws of Maryland and are not the year of enactment. Chapter references refer to those laws enacted by the General Assembly and are both the year of enactment and the year of the Session Laws.
