Preface

A cumulative compilation of the changes to the codes of public local laws that have *not* been incorporated and published in a supplement or new edition of a local code is prepared annually by the State Department of Legislative Services in accordance with § 2-1245 of the State Government Article. The document is not intended to be an official updating of the Code of Public Laws of Maryland but rather is prepared to serve as a guide to the current status of the public local laws of the counties and Baltimore City.

Note that in the case of Anne Arundel, Calvert, Montgomery, Wicomico, and Worcester counties, no information with respect to changes is set forth in this document because those counties have incorporated and published the most recent changes to their codes in a supplement or new edition, as indicated on their respective pages.

The compilation includes the municipal corporations within each county, along with their chapter and volume references to the *Compilation of Municipal Charters*, a document that is also prepared by the Department of Legislative Services and updated annually. It should be noted that municipal corporations that are located in two counties are indicated by a double asterisk (**).

Chapter and year references in this document refer to those public local laws codified in county codes and passed by the General Assembly for those counties that do not have local home rule authority. However, in cases in which provisions under a particular listing indicate only a year and page number, those provisions were enacted by the jurisdictions that have local home rule authority. In those instances, the page references are to the pages in the annual session laws published by the Department of Legislative Services that contain the titles of the 2004 enactments of jurisdictions with local home rule authority.
