Outreach Efforts

The State Treasurer's website has all necessary documents to be completed for inclusion on the Approved Broker Dealer List readily available.

All Broker/Dealers listed on the MDOT MBE/DBE have been contacted. The necessary documents for inclusion on the Approved Broker/Dealer List are listed on the STO website.

Broker dealers who have inquired about obtaining business with the State have been informed of our policies and procedures and invited to submit the necessary paperwork to become an approved Broker/Dealer.

Everyone who has requested a meeting has received a meeting for further explanation of our policies and procedures.

MBE/VET/WBE Broker/Dealer lists from the major issuers of government debt have been requested and received as a source to be utilized for portfolio purchases.

The Office recently established and developed a relationship with Federal Home Loan Bank Diversity and Inclusion outreach program. This program promotes the utilization of minority broker dealers when opportunities exist for investment purchases.

The Investment Division solicited the major issuers of government issued debt for their list of minority/diversified broker dealers to be a source for purchases of Agency debt for the State portfolio.

The Office recently initiated a search to identify and solicit minority broker dealers that may participate in Repo (repurchase agreement) trades, which account for the majority of State trades, in hopes of further increasing the representation of minority business.
