- Fiduciary Responsibility requires selection of best price/yield
- All Transactions including Repurchase Agreements done on DVP Delivery vs Payment basis, Money is not exchanged until securities received by STO's Securities Custodian – Wilmington Trust

Overall Investing highlights

- The STO had done ~ \$192,304,126B in transactions in FY2022
- The bulk of those transactions were done in Repurchase Agreements with the STO doing approximately 86% or $\sim $170B$ in that investment space
- Much of the investment strategy was defensive given that the Federal Reserve started raising rates and Cash and Cash alternatives were the best asset to both shorten duration in portfolio and increase returns.
- Out of the remainder the STO total transactions approximately 56.5% was transacted with MBE / VET / WBE firms

Outreach Efforts

The Website has all necessary documents for inclusion on the Approved Broker Dealer List readily available.

All Broker/Dealers listed on the MDOT MBE/DBE have been contacted. The necessary documents for inclusion on the Approved Broker/Dealer List have been sent.

The National Association of Securities Professionals (NASP) provided their list of Member Firms. All firms identified as Fixed Income providers were contacted and sent the necessary documents for inclusion on the Approved Broker/Dealer List.

Everyone who has inquired about business with our State has been informed of our policies and procedures either via phone or in person. They have been given the necessary resources and invited to submit the required documents to become an approved Broker/Dealer.

MBE/VET/WBE Broker/Dealer lists from other States have been requested and received from the Government Investment Officers Association (GIOA), Government Finance Officers Association (GFOA), National Association of Auditors, Comptrollers and Treasurers (NASACT), and the National Association of State Treasurers' (NAST) membership.

The STO had some success in adding an MBE broker to our pool of brokers for a major portion of our business:

Considering the high percentage of the STO's business that is done in Repurchase agreements, (short term security collateralized by a minimum of 102% high grade Mortgage Back or US Treasury collateral) the STO invested a lot of time in outreach to add an MBE Broker to our list of approved Repurchase transaction counterparties so that we could provide business to an MBE firm. We are extremely pleased to announce that we were able to execute a contract with ASL Capital Markets, Inc. This certified MBE/VSBE firm began doing business with our Investment Division during the 3rd quarter of FY2022. To date, the STO has done ~ \$8.6B with this broker. They are one of our daily counterparts for both overnight and term repurchase trades.
